WBSEDCL (ROPA) Rules, 2020 has been issued vide Office Order No. 1782 dated 22.02.2020, through which Pay and Allowances of the employees of the company have been revised. However, the revision of T.A. Regulations is yet to be made. In the meantime, a good nos. of applications for payment of Transfer Grant and Packing Allowance have been received from the employees of the company.

Now, in consideration of all the above, it is, hereby, ordered that the composite Transfer Grant i.e. Transfer Grant and Packing Allowance shall be payable to the tune of one month's Basic Pay (Pay in the Pay Band + Grade Pay) in the un-revised scale as on 31.12.2019 in case of transfer of an employee involving change of station on or after 01.01.2020 till revised T.A. Regulation is issued.

In case of excess payment, beyond above stipulation, already made to any employee shall be recovered forthwith.
