In order to attain uniform rates towards hiring of the DG Sets across the licensed area of WBSEDCL one

Rate Contract was formulated and issued vide O.O No 37 dated 28.11.2019 of the Chief Engineer (Dist):

WBSEDCL, read with subsequent amendment orders and the tenure of which was expired on 31.03.2020.

Therefore, the "Rate Contract" is required to be extended with due assessment of the existing rates, terms &

conditions as per actual site requirement, fulfilling the prevailing norms of the WBSEDCL.

In addition to the above, time to time various representations have been received from the site offices to

formulate one "New Rate Contract" for i) Erection of 160 KVA DTR and ii) Fixing of LT Panel Box

Completed with connections with PVC Cable & allied works & dismantling the same and return to store

(wherever is applicable).

Considering above, the Company Management of WBSEDCL has accorded approval towards issuance of the

"Rate Contract" with immediate effect and to be remain valid for next 2 (two) years.

A) Rate Contract for hiring of DG sets:

It is needless to mention that for backing up the power supply, the DG sets are used, especially in the events

of National Importance like Ganga-Sagar Mela, Kolkata Book-Fair, Various festivals, VVIP visits, different

official programme arranged by the Govt departments etc. It is also been experienced that the DG sets are

sometimes required in bulk quantity especially in the event like Ganga Sagar Mela to ensure the

uninterrupted power supply.

It is understood, setting up of DG sets comprises of different charges viz i)Daily Hiring Charge ii) Daily

Operator Charge iii) Operating Charge (including Fuel & Lubricant) iv) Transportation Charge.

#### Part-III

# General Terms & Conditions of the Contract for Hiring of DG sets:

- 1. The requisite DG set should be sound proof and included with Auto-Changeover switches.
- Necessary Log Sheet for assessing the working hours shall be maintained by the operator of the supplier and the WBSEDCL's personnel shall countersign it on regular basis.
- 3. The DG set shall have to be operated by the personnel of the supplier only.
- 4. The hired charges shall include the maintenance and service of the DG set, shall be the obligation of the supplier. In case of malfunctioning of the DG sets, the supplier/vendor shall be obliged to replace the same on emergent basis without any extra charge. Any financial liability arising out of the malfunctioning of the DG sets will be on account of the supplier/service provider/vendor.
- 5. The safety is to be ensured by the service provider. In case of occurrence of any untoward incident like accident for the malfunctioning of the D.G sets, the WBSEDCL shall not be liable on any ground what-so-ever.
- Necessary maintenance and repairs of engine/alternator/ panel shall be carried out by the supplier at his risk and cost.
- 7. There shall be provision for alteration of hiring charges (upward and downward) if the DG sets are used/retained at site (either in load/no-load running/free-run or in stand-by condition) for the sake of un-interrupted power supply for more than 8 hrs on pro-rata basis subject to the maximum of 12 Hrs.
- In case of exceptional & demanding circumstances, DG set is run (load/free run) round the clock or more than 12 Hrs, the necessary approval should be obtained from the Chief Engineer (Dist): WBSEDCL.
- 9. The road-transportation cost is to be considered as to and fro basis on actual shortest route. However, the maximum allowable distance is to be considered from the District Head Quarter to the point of installation/use.
- 10. River Transportation rate shall be guided by as per TABLE- Part-II (to and fro) basis, on production of voucher from the appropriate authority, preferably.
- 11. Performance Bond need to be submitted in the form of PBG/Draft/Cash @ 10% of the contract value, on refundable basis as per norms of WBSEDCL.
- 12. The admissible GST shall be paid extra as per Govt norms & rates, applicable during the period of time of use.
- 13. The rate contract shall be valid up for two years from the date of issuance of the order.

#### (B) Rate Contract for Erection of 160 KVA DTR (Complete with all fittings O/D Type):

The rate for erection of 160KVA DTR (Complete with all fittings O/D Type) is Fixed as **Rs 3406.00** (excluding of Taxes) per DTR

# (C) Rate for Fixing of LT Panel Box Completed with Connections:

The rate for Fixing/Erection of LT Panel Box Completed with connections with PVC Cable & allied works & dismantling of the same and return to store (if required) complete in all respect is Fixed as **Rs 2326.00** (excluding of Taxes).

For item No (B) & (C) above, GST shall be applicable extra as per Govt norm, applicable during the period & time of execution of works.
