Gist of Application for Fuel and Power Purchase Cost Adjustment and Annual Performance Review for the year 2018 – 2019

1. West Bengal State Electricity Distribution Company Limited (WBSEDCL) has submitted applications before the West Bengal Electricity Regulatory Commission (Commission) for Fuel and Power Purchase Cost Adjustment (FPPCA) for the year 2018 – 2019 on 26.10.2021 and Annual Performance Review (APR) for the year 2018 – 2019 on 24.11.2021. The FPPCA application has been admitted on 26.01.2022 in Case No. FPPCA - 102/21 – 22 and the APR application has been admitted on 21.01.2022 in Case No. APR – 89/21 – 22 by the Commission.
2. The gist of the FPPCA and APR applications is as follows:
The FPPCA application is for approval of net Fuel and Power Purchase Cost of Rs 1522229 lakh and the APR application is for approval of Rs 628147 lakh towards Net Fixed cost for the financial year 2018 – 2019. WBSEDCL accordingly seeks to recover net revenue shortfall of Rs. 191916 lakh for the year 2018 – 19.
