GTCC.2.REGULATORY MECHANISM

Supply/ Deployment/ Engagement of security personnel shall be regulated in terms of Private Security Agencies (Regulations) Act, 2005 read with the Private Security Agencies Central model Rule, 2006 and any other rules framed by the appropriate /controlling Governing authority under the Act. All security personnel shall be well disciplined at work and punctual at the time fixed and notified to them. Late attendance and irregular attendance including early departure constitute a breach of discipline & punishable being act of misconduct. 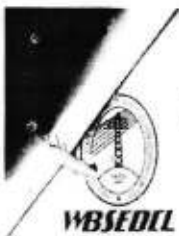

2. Scope of Work and other terms and conditions shall be as per details indicated in this order.
3. The LOA shall be issued by respective zones and shall be guided by different clauses as mentioned in the order.
4. Order shall be issued from the respective WBSEDCL Zones only to the enlisted vendors.

5. Order shall be issued as per the rate mentioned. This rate per year will be firm for the entire respective year.



- 1.2 Vendor will provide the service towards collection of payment against energy bills through out West Bengal in respect of Low and Medium Volt Consumer through the cash collection center on behalf of WBSEDCL. The mechanism of WBSEDCL bill payment and collection service is appended below.


