- 1. Regular employees of WBSEDCL and employees deputed by the Company to other organizations may apply under this Circular, if eligible.
- 2. Only eligible confirmed employees of WBSEDCL will get age relaxation up to the age of 45 years irrespective of their Caste/ Category.
- 3. Departmental candidates of WBSEDCL, who are not confirmed, may also apply under this Circular. In such cases, the age relaxation up to 45 years shall not be applicable; instead, the upper age limit will be as mentioned under the "Age Limit" Section of the Notification

- 4. Departmental Employees who are confirmed in their service shall have to enroll themselves by selecting the Radio Button "Yes" using the option "Are you an applicant under WBSEDCL's Departmental Circular for this Notification".
- 5. However, Departmental Employees who are yet to be confirmed in their service shall have to enroll themselves by selecting the Radio Button "No" using the option "Are you an applicant under WBSEDCL's Departmental Circular for this Notification".
- 6. It will be the candidate's prerogative to ensure that they fulfill the eligibility criteria before applying. In case, it is detected at any stage of recruitment/selection that a candidate does not fulfill the prescribed eligibility norms and/or that they have furnished any incorrect/false/wrong information or has suppressed any material fact(s), their candidature will automatically stand cancelled.
- 7. "Domicile of West Bengal" forms a mandatory criteria for determination of eligibility of candidates for recruitment to various induction levels posts as per Recruitment Policy w.r.t regular employment under WBSEDCL and same the will be applicable for Departmental Employees as well.
- **8.** There will be no separate communication to any candidate on their non-selection at any stage.
- 9. Departmental employees belonging to the SC of West Bengal or ST of West Bengal or PwBD (Person with Benchmark Disability) category are exempted from paying any application fee.
