

EXPRESSION OF INTEREST - OBJECTIVE

West Bengal State Electricity Distribution Company Limited (WBSEDCL), a Govt. of West Bengal Enterprise came into effect from **01.04.2007** after restructuring of erstwhile West Bengal State Electricity Board in compliance of Electricity Act, 2003. WBSEDCL is major power utility in the state of West Bengal and is engaged in the business for distribution of electricity and hydro-generation.

WBSEDCL is planning to enlist agencies/firms of repute with competence and experience for Recruitment process outsourcing. WBSEDCL with a current manpower strength of around 14,000 employees is planning to recruit about 4000+ of fresh manpower across various cadres within the next 4 (Four) years. The agency/firm should have appropriate knowledge and expertise in handling end to end recruitment process. Adequate knowledge of the prevalent 100 Point Roster system under Govt. of West Bengal is essential.

All the recruitment process will take place in the State of West Bengal. The enlistment will be valid for a period of 2 (two) years and may be extended based on mutually agreed terms and conditions. The enlistment may also be terminated by WBSEDCL with a prior notice.

SCOPE OF WORK

- ✓ Designing of Portal for receiving of Application Online.
- ✓ Scrutiny of Application submitted Online.
- ✓ Collection of Application fees using Bank Challan or Online payment mode.
- Receiving of hard copy of application and thorough verification of documents.

- ✓ Undertake all steps for conducting of Written Test (i.e. Issuance of Admit Card, Designing of Question Paper/Evaluation through Double Scanning of OMR Answer Sheet & Arranging of Standard Venues)
- ✓ Conducting of Computer Proficiency Test/Personal Interview.
- ✓ Compilation & submission of Merit List.
- ✓ Time of completion of entire project is 100/120 days from the date of publication of the notification in the Newspapers.
- ✓ Designing and conducting process of "PSU Recruitment through GATE" model.

##This EOI is only for Enlistment of Eligible Agencies and in the real event, each case will be finalized by way of competitive bidding through limited tender amongst the enlisted agencies on each advertisement on vacancy basis.

PROJECTED RECRUITMENT

WBSEDCL is tentatively planning to recruit about **4000**+ fresh manpower (including both Technical & Non-Technical) for various induction level posts across varied nos. of cadres.

ELIGIBILTY CRITERIA FOR ENLISTMENT

- 1) The agency should have handled at least **10** examination activities against different advertisements for various organizations and atleast one in West Bengal. The examinations mentioned for all the posts will take place in the State of West Bengal.
- 2) The agency must have processed a total number of applications above **5000** per recruitment with at least one recruitment consisting of **50,000 1,00,000** or more applications against single advertisement.
- 3) The onus of secured printing and its confidentiality lies with the vendor. The software used for conduct of examinations should be tested before it is brought into use and to be certified, from reputed technological firm/company.
- 4) The agency should have at least 30+ persons working on permanent roll of the company.
- 5) The agency must have successfully handled and completed end to end recruitment/selection process including Written Test or Computer Based Test (CBT) for Departments of Central Government, State Government/PSUs/ Public Sector Banks/ Academic Institution of National Repute during last 3 (Three) Financial Years ending 31.03.2017. The consultant firm/ agency should submit the details of such assignments undertaken.
- 6) The agency should have at least 2 (Two) offices running under the banner of bidding company across India. The details like addresses, contact number etc to be submitted for the establishment of the required geographical reach across India. The company should have atleast one permanent office in West Bengal with adequate permanent manpower and infrastructure facilities.
- 7) The Agency must have yearly turnover of at least **Rs. 50 lakhs** during last 3 (Three) financial years (**FY 2014-15, 2015-16 & 2016-17**) from recruitment or related job.
- 8) The Agency / Firm must have the capability to process applications, and must have experience of registration through online / offline mode and handling offline / hard copies of applications and documents as per requirement. The agency must have sufficient experience in conducting written examination in multiple venues, conducting interview for the eligible candidates through engaging expert in the respective field and submission of final merit list of the selected candidates.

- 9) The Agency / Firm must have successfully completed recruitment work for Govt. Departments / Central PSUs / State PSUs / State Govt. / Statutory Corporation for an order value of Rs. 10 Lakhs or more per order and at least three such orders will have to be executed during last three financial years (FY 2014-15, 2015-16 & 2016-17).
- 10) The agency must have sufficient infrastructure for processing applications on-line through IT infrastructure, competent and technically / professionally qualified manpower of required number for conducting selection process involving minimum 5,000 or more applications in each case.
- 11) The Recruitment Agency must have sufficient storage space to keep the examination related documents for at least 3 years on behalf of the Company, in case of conducting selection.
- 12) The Agency must have experience for conducting large public examinations with multiple venues and experience for conducting interview for professionally qualified candidates from open market through engagement of experts in the concerned fields and in other allied matters including submission of merit list as per Govt. guidelines.
- 13) An Unregistered Partnership / Firm or Society shall not be eligible to apply.
- 14) The Agency / Firm shall, during the entire period of contract place in position a core team consisting minimum three key personnel who are professionally qualified in the respective field and well experienced in recruitment process. The Agency / Firm, on being enlisted, shall furnish the details of the core team with their name, designation, qualification and contact no. to WBSEDCL in case of assigning any particular project on successful bidding. The core team so engaged shall remain unchanged throughout the period of a particular recruitment project.
- 15) Out sourcing of any job at any stage of recruitment (if assigned to the agency on being enlisted) by the agency without permission of WBSEDCL authority is strictly prohibited.
- 16) Enlistment will be done strictly as per eligibility criteria. Interested agencies are requested that they must satisfy all the eligibility criteria before applying for enlistment.
- 17) Co-operative societies for hand delivery of energy bills, security agencies, manpower hiring agencies, self help group, housekeeping agencies, outsourcing agencies, consortium etc. are not eligible to take part in the process of enlistment.
- 18) On being enlisted, the Agency has to deposit a sum of **Rs. 1,00,000/-** (One Lakh) only through Demand Draft drawn in favour of West Bengal State Electricity Distribution Company Limited, payable at Kolkata as Security Deposit.
- 19) The enlistment shall be valid for a period of **2 (two) years** from the date of enlistment. Terms of enlistment may be extended by suitable period on same terms and conditions subject to decision and approval of competent authority.
- 20) WBSEDCL, may, at any point of time without assigning any reason, cancel the enlistment without any liability by giving 30 days notice.
