NOTIFICATION

The need of providing various services through the Online Mode in view of the Ease of Doing Business (EoDB) is under active consideration of the State Government for some time past in view of the EoDB requirements and in compliance with BRAP-2022 under EoDB. Now **the Department of Power, Government of West Bengal has introduced the following services through Online Mode only –**

1. **Approval for DG Set installation by the Directorate of Electricity** via online system, URL: www.tathyasathi.bangla.gov.in
2. **Issue of Encumbrance Certificate/ No dues certificate for the Electricity Charges by West Bengal State Electricity Distribution Company Ltd. (WBSEDCL)** via online system, URL: https://www.wbsedcl.in/irj/go/km/docs/internet/new_website/noDues.html (which will be issued in real-time through online system, without requirement of any fee/ document).

For successful implementation of the online services for Approval for DG Set installation by the Directorate of Electricity and Issue of Encumbrance Certificate/ No dues certificate for the Electricity Charges by WBSEDCL, the following mandate shall be followed –

- i. All applications shall be submitted online and no offline application shall be entertained.
- ii. All payments of fees including application fee as applicable to be deposited online for Approval for DG Set installation. No fee is required for Encumbrance Certificate/ No dues certificate for the Electricity Charges (West Bengal State Electricity Distribution Company Ltd.). Fee details, procedure and comprehensive checklist of documents required to be uploaded, as applicable for each of the services, are available in respective portals as mentioned in Sl. 1. & 2., above.
- iii. Tracking the status of application online, for Approval for DG Set installation. The Encumbrance Certificate/ No dues certificate for the Electricity Charges (West Bengal State Electricity Distribution Company Ltd.) is issued in real-time and so tracking is not required for this service.
- iv. The Final Signed Approval Certificate can be downloaded from the online system.
- v. Online verification of the genuineness of the certificate can done online by any third party, of the Approvals for DG set installation issued (Online Third Party Verification).

This Department has also issued Notifications and published the same in the Kolkata Gazette under the West Bengal Right to Public Service (WBRTPS) Act, 2013 mentioning the stipulated timeline for the DG set approval vide no. 644-POW dated 06/09/2022 and No Dues Certificate vide no. 564-POW dated 18/08/2022.

This Notification, issued in the interest of public, will take immediate effect.


