Rate Contract Order issued vide above referred memo for enlistment of Supply & Delivery of G.I. Stay Set - H.T. & L.T. and G.I. Earth Spike, against Tender No. P-02/2015-16/GISS/RC/PC-III due on 12.05.2015 was valid from 01.01.16 to 31.12.17(i.e. for 2 years).

Validity Period of the same R.C. Order, i.e. Rate Contract for Supply & Delivery of G.I. Stay Set - H.T. & L.T. and G.I. Earth Spike, is hereby extended by six month with effect from 1st January' 2018, keeping all the terms and conditions & revised rate(in GST regime) of Original Rate Contract Order unaltered. The extended period of validity will end on 30.06.18.

The Manufacturer, who were enlisted for the above mentioned Rate Contract Order, are only eligible for this extended period as they have already agreed to accept the extension of validity keeping all the terms, conditions and revised rates in the GST regime unaltered during the extended period.

The Manufacturer will be eligible to perform as enlisted vender under this Rate Contract for this extended period, after extension of the validity of the Bank Guarantee up to 30.06.2019 with a claim period up to 31.12.2019, which have been already submitted as Earnest Money Cum Security Deposit. Those who had deposited Earnest Money Cum Security Deposit of Rs. 1,00,000/- through Bank Draft, they have to agree to retain the same with us up to 31.12.2019. This confirmation/Extension of BG, should be done within 15 days from the issue of this letter.
