These securities are listed with Bombay Stock Exchange in Wholesale Debt Market The Financial Statements have taken into account the effects of the revised operating norms for the Distribution utilities, which were notified through Regulation 76 of WBERC on 13.03.2023,
- read with the Regulation 2.5.5.4(amended) of the Principal Regulation. The previous period's figures have been regrouped / reclassified / re-measured wherever necessary to confirm current period's classification.
- The Financial Statements of West Bengal Green Energy Development Corporation Limited (WBGEDCL), only Associate Company of WBSEDCL has been considered for preparation of Consolidated Financial Statement based on management certificate obtained in this regard.
- Ratios are calculated on annualized basis.
