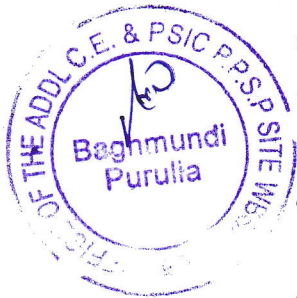

- 1) West Bengal State Electricity Distribution Company Ltd. (WBSEDCL) invites sealed quotation from competent, resourceful and registered agency for **Supply and Delivery of Fire Extinguishing Materials at site and Refilling of Fire Extinguishing Cylinders** as per the specifications mentioned in Annexure-I for Purulia Pumped Storage Project Site. The sealed cover shall be super scribed with "NIT No" Name & Date of the Tender and "Date & Time of opening of the Tender".
- 2) Scope of Work: **Supply and Delivery of Fire Extinguishing Materials at site and Refilling of Fire Extinguishing Cylinders** as per the specifications mentioned in Annexure-I at Purulia Pumped Storage Project Site, Bagmundi, Purulia within the stipulated time period.

Terms and Conditions:

1. Scope of work:

- A) Supply of Fire Extinguishing Materials at site which will be required for refilling are included in the scope of vendor. The agency should arrange transportation of the refilling consumables to PPSP Site as per specifications mentioned in "Annexure-I" without any additional charges to WBSEDCL.
- B) All types of fire extinguishers have to be refilled in premises of PPSP Site in presence of PPSP Site officials. In case the fire extinguishers which could not be refilled at PPSP Site (i.e. stored pressure N₂ type, CO₂ Type and Water stored pressure type), those fire cylinders must be collected from PPSP Site by the vendor at their own cost, risk and responsibility and must be delivered to PPSP Site after refilling of the same within the Re – filling period.
- C) All types of fire extinguishers are placed in various location of PPSP Site. The vendor must collect the fire cylinders from different location of PPSP Site and must deliver the refilled fire cylinders to each location at their own cost, risk and responsibility following safety precautionary measure of PPSP Site.
- D) Actual time schedule of refilling of fire extinguishers should be finalized after discussion with PPSP Site authority.

2. Re-filling Period: All types of fire extinguishers have to be refilled within 10 Days from placement of order.

3. Place of delivery & Refilling: The re – filled Fire Extinguishers will be delivered at different locations of PPSP Site, WBSEDCL, Bagmundi, Purulia – 723152. No delivery cost will be reimbursed to the agency.

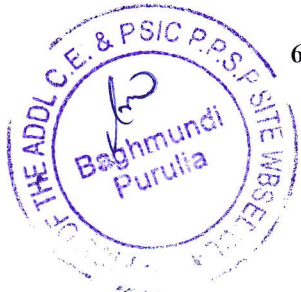
4. Force Majeure: The agency shall have no liability if the agency is prevented from carrying out any of (whether declare or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods, Govt. Order and or restrictions(except power supply restriction) delay or inability to obtain materials due to import or other statutory restriction and other cause beyond the reasonable control of the agency. However such force majeure circumstances are to be intimated immediately and to be established subsequently with proper document/proofs to the entire satisfaction of the PPSP Site authority.

5. Price: Price should be firm inclusive of all incidental charges whatsoever except GST. GST should be mentioned separately as applicable.

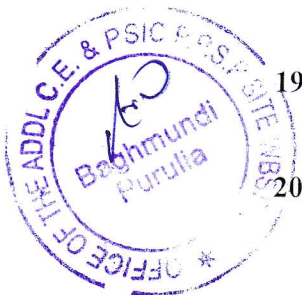
6. Payment: 90% Payment will be made after successful refilling of fire extinguishing cylinders, drawal of Service Entry Sheet from this end, submission of work completion report, original bill in GST Tax Invoice in triplicate with advanced pre-receipt (Duly signed on Revenue Stamp), Guarantee/ Warranty/ Validity Certificate & Challan. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency. Balance 10% of the amount will be kept at Security Deposit and the same will be refunded after expiry of Guarantee/ warranty/ validity period on receiving application from the vendor's end.

7. Additional Performance security: As per norms of WBSEDCL

8. Statutory Deductions: Statutory deductions if any will be deducted from the bill of the agency as per rule.



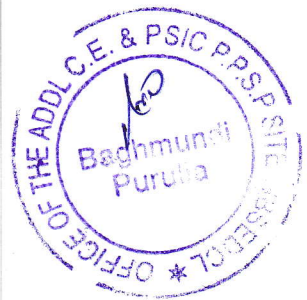
9. **Additional Liabilities:** The WBSEDCL shall not take any additional liability towards enhanced taxes, duties beyond the scheduled delivery period as incorporated in the purchase order, if the delay is due to any failure on the part of the agency.
10. **Transit Insurance:** In the scope of the agency.
11. **FOR:** Purulia Pumped Storage Project Site, Baghmundi, District: Purulia, PIN: 723152.
12. **Packing & Forwarding:** If Fire Extinguishing Cylinders (Water Stored pressure type Fire Extinguishers, Dry chemical powder, stored pressure N₂ and CO₂ type Fire Extinguishers etc.) are required to be sent at factory for refilling, the vendor should take all reasonable precautions to protect the materials against damage and loss during transit. The bidder shall bear total responsibility against any losses & damages during transit. The transportation charges will be borne by the agency without any additional financial involvement on WBSEDCL.
13. **Penalty:** Penalty for delay in refilling @1/2 % (half percent) of value of order for each week delay or part thereof up to ten (10) weeks and @1% of the order value per week or part thereof beyond ten (10) weeks subject to maximum limit of 10% (Ten percent) of the order value will be deducted from the agency.
14. **Guarantee/ Validity:** Guarantee/Warranty/Validity certificates are to be provided for a minimum period of 02 (Two) years for CO₂ type fire extinguishers and 01 (One) year for all other type of fire extinguishers. In case the re – filled Fire Extinguishers or Fire Extinguishing Materials are beyond our specification or found defective/damage /broken within the guarantee / warranty/ validity period, the same should be replaced by the agency at their own risk, cost and responsibility within 15 days of intimation.
15. **Freight:** It will be borne by the agency. No delivery cost will be reimbursed to the agency.
16. **Vendor Details:** PAN No., GSTIN No., Trade License, Bank NEFT/RTGS details are to be provided for vendor approval along with a cancelled cheque. Credentials – if any, are to be submitted along with the offer.
17. **Validity of Offer:** The offer must remain valid for 60 days from the date of opening of the tender.
18. **Rejection:** WBSEDCL reserves the right to reject any or all offer at its own discretion without assigning any reasons whatsoever and do not bind itself to accept the lowest tender.
19. **Risk Purchase Clause:** Risk Purchase Clause will be applicable as per norms of WBSEDCL.
20. **Demonstration:** Random demonstration of workability of refilling fire extinguishers of one of each type has to be made at PPSP Site at the time of installation, free of cost.
21. **Credentials:** Bidders should have previous experience (at least one) of successfully executing similar type of job. Supporting relevant documents are to be submitted at the time of submission of quotation.

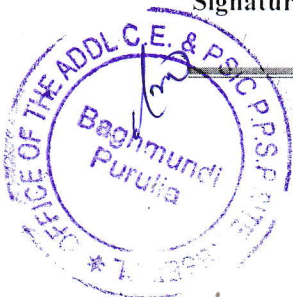
