### **GENERAL TERMS AND CONDITIONS:**

#### **1. ELIGIBILITY CRITERIA:**

- A) The agency should be an Authorized Dealer or Channel Partners of PHILIPS.
- B) The agency should possess GST registration.
  - The agency should submit a copy each of Authorized Dealer Certificate and GST Registration Certificate along with the offer.

#### **2. TENDER:** The tender shall consist of:

- A) The quotation on firms own letter head as stated above.
- B) A self-attested copy of Authorized Dealer Certificate.
- C) A self-attested copy of GST Registration Certificate.

#### **3. SUBMISSION OF TENDER:**

Notice Inviting Tender (NIT) will be made available in the website of WBSEDCL ([www.wbsedcl.in](http://www.wbsedcl.in)) for downloading and displayed at Notice board of above office from **23-09-2021 at 10:00 hrs**. The tender will be received at the above office up to **27.10.2021 till 17:00 Hrs**.

#### **4. OPENING OF TENDER:**

The tender will be opened on **28.10.2021 at 14:00 Hrs** in the presence of the attending tenderers.

#### **5. SCHEDULE OF SUPPLY:**

6. **Quoted Rate:** The price quoted by the agency should be firm and exclusive of GST. GST shall be extra.
7. **DELIVERY PERIOD:** The Materials shall have to be delivered at site i.e. (Rammam Hydel Project stage II, Lodhomahat, Dist. Darjeeling) within 4 (four) weeks from the date of placement of order.
8. **TAXES & DUTIES:** Taxes & duties, if any, are to be mentioned clearly and shall be reimbursed as per prevailing norms. (GST shall be extra as per norms and IT @ 2% may be deducted if required)
9. **PAYMENT:** 100% (One Hundred percent) payment along with GST & F&I will be paid after satisfactory receipt of materials at site (Rammam Hydel Project stage II, Lodhomahat, Dist. Darjeeling). Payment shall be made through fund transfer against receipt of bill and challan in triplicate. The Agency shall have to submit their bank account details in the offer. Bank charges if any shall be borne by you.
10. **VALIDITY:** The Tender / Quoted Rates shall remain valid for 90 (ninety) days from the date of opening.
11. **GUARANTEE:** Materials shall have to be guaranteed for 12 (twelve) months from the date of installation or 18 months from the date of delivery whichever is earlier, against manufacturing defect. The Agency shall submit a Guarantee Certificate along with the invoice during the time of delivery.
12. **LIQUIDATED DAMAGES:** Liquidated damages @ ½ (half) % per week up to 10(ten) weeks and @1% beyond that, for delay in supply or part thereof subject to a maximum of 10 (ten) % will be imposed for non-delivery of materials after lapse of the stipulated period.
13. **RISK PURCHASE:** The time of delivery or stipulated in this purchase order shall be deemed to be the essence of the order and If you fail to deliver any consignment within the period prescribed for such delivery as mentioned above, WBSEDCL shall be entitled to purchase such consignment or if not available, the best and nearest available substitute elsewhere on your account and at your risk or to cancel the order and you shall be liable to compensate for any loss or damage which WBSEDCL may sustain by reason of such failure on your part.

15. **CONSIGNEE:** The Divisional Engineer (M) & Store I/C, Rammam HP, St-II.
