Tenders are invited by the Addl. Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from Reputed Agencies for the work detailed below on percentage rate basis:

- Name of the work: AMC for regular maintenance of 3Ph LT line including LTOH line, street-1. lights, electric wiring and power supply to installations in establishments / buildings inside the Township Complex of TCFHP at Phansidewa, Distt: Darjeeling.
- Estimated Cost: ₹ 11,35,320.96 (Rupees eleven lakh thirty five thousand three hundred 2. twenty & paise ninety six only). GST will be paid extra as per statute.
- Average Annual Estimated Cost: ₹ 5,67,660.48 (Rupees five lakh sixty seven thousand six 3. hundred sixty paisa forty eight only) excluding GST.
- Period of Contract: 24 (twenty) months. 4.
- Eligibility criteria: The intending bidders must have: 5.
 - Credential for successfully execution of any electrical maintenance at WBSEDCL / other i) Power Utilities / other Govt. Departments / PSU in earlier occasions within last 07 (seven) financial years. Ordered value of the work on a single contract should not be less than 50% of average annual estimated cost excluding GST.
 - Valid Electrical Contractors' License with suitable Supervisory Competency Certificate on apii) propriate parts.
 - Other requirement: All categories of the prospective bidders shall have to submit the followiii) ings:
 - a) Employees' Provident Fund
 - b) GST Registration certificate and GSTR3B for last one year.
 - c) E.S.I. Registration no. (or declaration for obtaining ESI)
 - d) P. Tax Registration certificate and enrolment certificate, if any.
 - e) PAN Card
 - f) IT Return for the last three years
 - g) Valid Trade License.
- Earnest Money Deposit: All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) of ₹ 14,192/- (Rupees fourteen thousand one hundred ninety 6. two only) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (https://wbtenders.gov.in) online. Details regard-



ing the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.

- 7. In the event of e-filling intending contractors/bidders desirous of participating in the e-Tender should download the tender documents from the website http://www.wbtenders.gov.in directly with the help of Digital signature Certificate.
- 8. Both **Technical Bid and Financial Bid** are to be submitted concurrently duly digitally signed by the Bidder through the website https://wbtenders.gov.in and should be submitted online on or before as per the 'Date &Time Schedule'.
- 9. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
- 10. No mobilization advance and secured advance will be allowed.
- 11. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
- 12. The offer against tender should remain valid for a minimum period of 120 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
- 13. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in http://www.wbsedcl.in website.

- 17. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
- 18. Conditional / Incomplete tender will not be accepted under any circumstances.
- 19. The intending Bidders are required to quote the rate online at www.wbtenders.gov.in
- 20. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 21. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
- 22. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria.
