NOTICE INVITING e-TENDER

Tenders are invited by the Addl. Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from manufacturers /authorised dealers/Reputed Agencies for the following item as per schedule detailed below **on item rate basis**:

- 1. Name of work:** Supply & commissioning of Microcontroller based Annunciation box (Make: Bharani, Alan, Minilec) including necessary materials i.e blanking plate, control cables, connectors & printed ferrule etc. as required for completing the installation & commissioning work of Microcontroller based Annunciation box. Panel cutting, necessary modification and alteration of wiring as per instruction of controlling officer at the site of PS-I, PS-II and PS-III under TCFHP, WBSEDCL.

**WBSEDCL**

2. **Earnest Money Deposit:** All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) of ₹ 42,833/- in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. Details regarding the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.

3. **Eligibility Criteria:** The intending bidders must have:
 - i) The bidders shall have credential for similar types of work at WBSEDCL / other Power Utilities / other Govt. Departments / PSU in earlier occasions within last 07 (seven) financial years. Ordered value of the work on a single contract should not be less than 25% of estimated tender cost excluding GST. Following type of work will be taken as similar work.
 - A) AMC of TG Sets, switchyard.
 - B) Supply or supply & installation of micro controller base annunciator/ relay control panels/ relay control panel spare parts.
 - C) Work for maintenance of annunciator panels / relay control panels/ relay control panel spare parts.
 - ii) Valid Electrical Contractors' License with suitable Supervisory Competency Certificate on appropriate parts.
 - iii) GST Registration certificate and GSTR3B for last one year.
 - iv) Up to date P. Tax clearance certificate.
 - v) PAN Card
 - vi) IT Return for the last three years.
 - vii) Valid Trade License.

4. Both **Technical Bid and Financial Bid** are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in> and should be submitted online on or before as per the 'Date & Time Schedule'.

5. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.

6. No mobilization advance and secured advance will be allowed.

**WBSEDCL**

7. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
8. The offer against tender should remain valid for a minimum period of 120 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
9. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in <http://www.wbsedcl.in> website.

12. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
13. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
14. Conditional / Incomplete tender will not be accepted under any circumstances.
15. The intending Bidders are required to quote the rate online at www.wbtenders.gov.in
16. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

**WBSEDCL**

17. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the bidder.
18. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
19. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one bidder without assigning any reason whatsoever.
20. Revised Purchase Policy will be followed wherever applicable in respect of the contract work. Revised Purchase Policy is available at company's website.
21. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
