- (ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax Receipt Challan, P.F. Registration number with current return/challan, GST Registration no. with current return/challan (if any) of, E.S.I. Registration no (for execution of works in ESI coverage area) with current return/challan, PAN Card and Income Tax Return for last three Assessment Years i.e. **2022-23, 2021-22, 2020-21** in respect of the prospective Bidder. Proprietorship Firm (Trade License). Partnership Firm (Partnership Deed, Trade License). Ltd Company (Incorporation certificate, Trade License). Co-operative Society (Society Registration copy, Trade License). [Non-statutory Documents]
 - (iii) Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debaring will be considered as disqualification towards eligibility.  - (iv) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years.  - (v) No conditional / Incomplete Tender will be accepted under any circumstances.
4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL.
