#### **BACKGROUND**:

The West Bengal State Electricity Distribution Company Limited (hereinafter called as WBSEDCL) is a Government of West Bengal Enterprise engaged in catering power to 96% (ninety six percent) of the geographical area of WBSEDCL and has vast electrical network and large numbers of Electric Poles (PCC/RAIL/STEEL TUBULAR) spreading across the state of West Bengal under the command area of WBSEDCL. WBSEDCL is interested in letting out these huge numbers of poles situated at strategic locations alongside the road for the fixing of the optical fiber/Communication/Data Cables with accessories (maximum 10 numbers of cables in each pole).

#### **SCOPE OF WORK:**

At present WBSEDCL have approximately 300000 CKM of overhead LT network laying on PCC poles & other poles at a distance of 40-50 meter-approx (pole to pole) and around 190000 CKM of HT lines caters power across the state of West Bengal (under the licensed area of WBSEDCL), out of which a huge numbers of poles can be utilized for the above purpose. There are huge windows of opportunities which can be explored for the laying/fixing of up to 10 numbers of optical fibers/cables on each of these poles beneath the LT network (maintaining the safe distance). Hence, telecom/cable Company may feel it attractive since huge window of opportunity is on offer on behalf of WBSEDCL.

# PERIOD OF CONTRACTS:

The WBSEDCL desires to arrive at a **Two years** rate-contract through competitive bidding (@ H1 rate i.e highest bidding rate), however that **may be flexible/may be further extended up to another one year subject to satisfactory performance of the agencies in terms of timely payment, fulfilling the existing terms and conditions of the contract etc, with the sole discretion of WBSEDCL.** 

Based on the quoted rate WBSEDCL may/shall formulate one rate contract and allot to the interested parties on first come first serve basis subject to availability of number of cables per poles (as maximum 10 (Ten) numbers of cables can be fixed on a single electric pole).

However, WBSEDCL may allot up to 5 (five) nos of cables/poles to the H1 (highest bidder) on demand and in that case the residual number of cables shall be allotted to other interested parties on first come first serve basis as per availability with matching rate with H1 bidder.

#### **PAYMENT TERMS:**

**100%** (Hundred Percent) up-front payment of the *value of the Contract (rent/licensee fees)* fixed for 1<sup>st</sup> year for letting out the actual numbers of Electric Poles of WBSEDCL is to be made within 15 (Fifteen) days of issuance of the permission letter by the site-engineer (i.e not below the rank of the Divisional Manager) at the respective Divisions, after issuance of formal Letter of Award by the Chief Engineer (Dist) to respective agencies after formulation of the Rate Contract.

Within 30 (thirty days) from the issuance of the permission letter by the Divisional Manager (s), the formal agreement needs to be executed with the party by the site-in-charge (not below the rank of Divisional Manager).

# <u>Section-IV</u>: <u>General Conditions of Contract (GCC)</u>

#### **GENERAL TERMS AND CONDITIONS OF BID**

#### **Title of the Electrical Installations:**

The right of electrical installations, such as poles and other attached accessories shall remain in the hands of the WBSEDCL and is not transferable under any circumstances.

#### **Description of the works**

- 1. The agency will obtain the right for laying/fixing of cable/optical fibers on Poles from WBSEDCL after the fulfillment of all clauses as laid down in the said tender.
- 2. The agency will pay all charges to get electricity connection from the WBSEDCL authority if required for such job.
- 3. The agency will abide by the standard Safety Policy as set out by the Govt body/WBSEDCL which may be amended from time to time.
- 4. The agency will pay all the statutory taxes to the appropriate authority/Local bodies.
- 5. Deviation of norms without prior permission of the WBSEDCL will lead to cancellation of the contract with forfeiture of EMD.
- 6. In the event of extension of electrical installation"/diversion of electrical lines the Installations (cables) has to be removed forthwith without any alternative site (s) after getting 7 days notice. In that case the advance/upfront payment made will be adjusted in pro-rated manner.
- 7. Periodical maintenance of the installations/Cables is mandatory with prior permissions of the site-in-charge.
- 8. This contract is for **Two years only** from the date of issuance of formal/work order. Which may be extended / curtailed based on the performance of the agency and discretion of the competent authority of WBSEDCL. The further 1 (one) years of extension may be considered upon the approval of the competent authority of WBSEDCL, based on the performance of the agency and other related issues.

#### Fixing/laying of OFC/Communication/data cables

- The agency shall have the right to lay/fix cables as per the awarding of the work order for a
  period of 2 years, which may be further extended by one year and curtailed with the
  discretion of management of WBSEDCL based on performance, prevailing market rate and
  parameters fixed by WBSEDCL.
- 2. If so demanded the license fees/LUC for letting out permission for laying of cables, the permission from the competent authority under relevant section, shall have to borne by the firm. - 3. The EMD of the successful bidder may be adjusted with the payable amount of the bidder (s) after signing agreement with appropriate authority of WBSEDCL.

- 5. After completing all formalities formal order will be issued based on the "Rate Contract" and agreement is/are to be executed, at the sole discretion of WBSEDCL.

The selected agencies need to respond to this notice within 15 (fifteen) days with sufficient details to the satisfaction of the Company (WBSEDCL), otherwise the WBSEDCL Authority will be issue a termination letter and taxes/ fees which has been deposited will forfeited. Termination of contract will debar any concerned agency to participate in any future tender invitation.

#### Right to accept and to reject any or all bids

1. The WBSEDCL reserves the right to validate all statements, information and documents submitted by the Agency /bidder in response to this Tender or the bidding documents and the Agency /bidder shall, when so required by the WBSEDCL, make available all such information, proof and documents as may be necessary for such authentication. Any such authentication or lack of such verification, by the WBSEDCL shall not mitigate the bidder of

its compulsions or liabilities hereunder nor will it affect any rights of the WBSEDCL there under.

2. The WBSEDCL reserves the right to reject any bid and appropriate the bid security if:- (a) at any time, a material misrepresentation is made or uncovered, or (b) the agency/bidder does not provide, within the time specified by the WBSEDCL, supplemental information sought by the Department for evaluation of the bid.

#### Precaution

- 1. The agency shall take all precaution to avoid any accident during fixing/maintenance of communication cable/OFC on the Poles. In the event occurrence of any accident, the agency shall solely be responsible to pay for the damages or any other consequences, whatsoever and WBSEDCL shall be kept unharmed. WBSEDCL shall have the liberty to undertake any required job like R&M, augmentation etc at any point of time.
- 2. The agency shall have to apply before nearby CCC for the electric connection (required if any) and bills of which are to be borne by the agency (if required). In case of any unauthorized use of electricity, the agency is liable to be prosecuted under relevant section of the Electricity Act'2003 (amendment up to date).
- 3. The mechanism to fix the cable along with the ground clearance and other technical specifications shall be under the sole domain of WBSEDCL.
- 4. Compliance of any sort of statutory liabilities as applicable during the entire period of contract will have to borne by the party.
- 5. The agency should not be allowed to use substandard materials to ensure the safety of the workers/employees of WBSEDCL AND GENERAL PUBLIC AS WHOLE. Regular maintenance of these installations (cables/OFC) are to be carried out with the prior permission of the site in charge.
- 6. In case of failure on the part of highest (H1) bidder within the stipulated time to comply criteria of WBSEDCL/expresses unwillingness / incapability within the stipulated time/any other reason arise in the course of evaluation, Authority's (WBSEDCL) decision towards forfeiture of EMD, Advance Bid Application Money will be final. In the event of such a situation H2 bidder & below, if agrees to take up the job/contract on the H1 rate may be permitted with the approval of the competent authority of WBSEDCL. In such event the rate contract shall be formulated @ H1 rate and H2 bidder shall be given the status of H1 bidder in terms of allowing up to 5 (five) number of cables per pole (in case of H2 bidder

- also fails, WBSEDCL may offer H3, H4......so on and so forth@H1 rate with reservation benefit)
- 7. Since, the objective of WBSEDCL is to formulate a rate contract through competitive bidding process, and slots may be given to participating vendors on first come first serve basis with reservation to the H1 vendor as per their actual requirement maximum up to 5 (five) nos of Cables per pole (which shall have to communicate to WBSEDCL within 30 days of formulation of the "Rate Contract" with preferred Districts/Location, otherwise reserved slot may be allocated to other interested parties), at the sole discretion of WBSEDCL.
- 8. Since, maximum 10 nos of cables can be allowed to be laid through the electric poles, the bidders/participants may be allowed to lay cable till attaining 10 numbers of cables per pole. However, that will come under the purview of consideration exclusively on the decision of the WBSEDCL authority which will be final and binding.

#### **Security Money**:

The agency shall have to deposit 10% of the total value of the contract for 2 years at respective Divisions in the form of DD/Cash/Cheque within 15 (fifteen) days of getting the permission letter from the Divisional Managers along with the up-front payment for the 1<sup>st</sup> year. The Security Money is refundable after expiry of three months of the contract (considering the extended period, if applicable) on satisfactory performance, as per norms of WBSEDCL.

#### Taxes & Duties:

The deduction of TDS is applicable as per Government rules and necessary TDS certificate is to be furnished to the WBSEDCL within 3 (three) months from the date of payment to the WBSEDCL.

#### <u>Tax</u>

GST, if applicable including any other related statutory tax, may be imposed shall be payable by the agency. WBSEDCL shall not be liable to pay any taxes, whatsoever.

Taxes would be applicable as per rules prevailing in Finance Act and subsequent amendment (if any). All the applicable tax provisions under GST shall have to be adhered by the agency.

#### In case of Tie

If two or more agencies make the same amount of offer for a single job then there will be a provision to split up the job equally among the bidders. In this regard the decision of WBSEDCL is final and binding.

#### **Penal Measure**

In case of non —payment of dues or in case of violation of any terms and conditions mentioned here in or for violation of any provisions of the WBSEDCL, laid down in the work order the agency will be black listed in participating in any advertisement related issues in future under jurisdiction of WBSEDCL and/or forfeiture of the Security Money and advance payment, removal of the installations from the electric poles.

#### **SELECTION PROCESS**

- Bids will be opened on the date and time mentioned in the schedule of events or such other later date as may be fixed by WBSEDCL by issuing a notice through the company's website/e-tender portal.
- 2. The bidder will be selected on the basis of evaluation of the bid, fulfilling all the criteria fixed in NIT.
- 3. The agreement on the aforesaid Job will be on the basis of the model agreement deed, shall be communicated subsequently.

#### **DISPUTE RESOLUTION AND ARBITRATION**

Any dispute between the parties arising out of this Bid Document or relating thereto or arising there from shall be settled by a method under the Arbitration and Conciliation Act, 1996.

The proceedings shall be conducted in English. The language of the proceedings and the Award shall be in English. The legal jurisdiction will be under Calcutta High Court.

# **Section-V: Scope of Work**

THE RIGHT TO FIX/LAY OF OPTICAL FIBER CABLES & DATA COMMUNICATION CABLES ON POLES WITH IN THE JURISDICTION OF WBSEDCL, SPREADING ACROSS THE STATE OF WEST BENGAL

The West Bengal State Electricity Distribution Company Limited (hereinafter called as WBSEDCL) is a Government of West Bengal Enterprise engaged in catering power to 96% (ninety six percent) of the geographical area of WBSEDCL and has vast electrical network and large numbers of Electric Poles (PCC/RAIL/STEEL TUBULAR) spreading across the state of West Bengal under the command area of WBSEDCL. WBSEDCL is interested in letting out these huge numbers of poles situated at strategic locations alongside the road for the fixing of the optical fiber/Communication/Data Cables with accessories.

#### **SCOPE OF WORK:**

At present WBSEDCL have approximately 300000 CKM of overhead LT network laying on PCC poles & other poles at a distance of 40-50 meter (pole to pole) and around 190000 CKM of HT lines caters power across the state of West Bengal (under the licensed area of WBSEDCL), out of which a huge numbers of poles can be utilized for the above purpose.
