NOTICE INVITING e-TENDER

The Chief Engineer, Hydel, WBSEDCL invites e-tender for the renovation and modernization work at Hydel Head Quarter Building, in two parts from the bona-fide, resourceful and technically eligible contractors having experience in similar nature of work as stated in the eligibility criteria mentioned herein under and '**Clause No.-7 of Instructions to Bidders (ITB)**' of this tender:

Terms and Conditions of the Tender Notice

1. Registration of Bidder

Intending eligible bidders, desirous of participating in the tender will have to be enrolled and registered with the Government of West Bengal e-procurement system and may download the tender document from the website <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC). The tender can be searched by typing WBSEDCL in the search engine provided in the above mentioned website.

2. Digital Signature Certificate (DSC)

Bidders willing to take part in the process of e-tendering are required to obtain Class-II or Class-III Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under the Controller of Certification Agencies (CCA), Govt. of India. The bidders are required to register the fact of possessing the digital signature certificates through the registration system available in the website. Tenders shall be submitted online and intending bidders should download the tender documents from the website stated above, directly with the help of the DSC. This is the only mode of collection of tender documents. Details of submission procedure are given in 'Clause No.-4 & 11 of Instructions to Bidders (ITB)'.

3. Tender Fee

The cost of the tender document shall be as per 'Clause No.-5 of Instructions to Bidders (ITB)'.

4. Earnest Money Deposit (EMD)

The amount and mode of deposition of earnest money of the said tender shall be as per 'Clause No.-19 of Instructions to Bidders (ITB)'.

5. Contract Performance Security

The contract performance security for the successful bidder shall be as per 'Clause No.-3 of General Conditions of Contract (GCC)'.

6. Bid Submission

Technical Bid and Financial Bid are to be submitted online through the website <https://wbtenders.gov.in> with the help of the Digital Signature Certificate (DSC) within the stipulated date and time.

7. The financial proposal of the prospective bidder will be considered only if the technical proposal of the bidder is found qualified by the tender inviting authority. The decision of the tender inviting authority will be final & binding on all concerned and no challenge against such decision will be entertained. In any circumstance or whatever may be the outcome of the present invitation of the bid, cost of the bidding will not be reimbursed/ returned by WBSEDCL. The list of techno-commercially qualified bidder(s) alongwith the ones whose bids are not qualified will be displayed in the website.
8. No mobilization advance and secured advance will be allowed.

Bid Validity

Bids shall remain valid for a period not less than 180 (One hundred eighty) days from the date of opening of FINANCIAL BID. If the bidder withdraws the bid before the period of bid validity, the earnest money deposited by him will be forfeited forthwith without assigning any reason thereof.

13. The intending bidder(s) are to quote their percentage rates online as per specified format/B.O.Q.

14. Disqualification of Bidders

Any evidence of unfair trade practices including over charging, price fixing, cartelization etc. as defined in various statutes, will automatically disqualify the bidders even if, the bidders meet the eligibility criteria described in 'Clause No.-7 of Instructions to Bidders (ITB)'. Details in this respect are given in the 'Clause No.-16 of Instructions to Bidders (ITB)'.

15. No agent is allowed to participate in the tender. Original contractor will only be allowed to participate in the tender.

16. Amendment of the Bid Documents

The tender inviting authority reserves the right to modify, amend or supplement the tender document. Any corrigendum, notification concerning this tender will be published in the e-tender portal <https://wbtennders.gov.in> and it will be treated as part and parcel of the tender. The bidders are, therefore, advised to follow the website for such corrigendum, notification etc.

17. Other information as well as terms and conditions, which are not covered above, will be made available in Instruction to Bidders, General Conditions of Contract, Special Conditions of Contract and Technical Specification of this tender.
18. All the important correspondence must be done through declared authorized email id with original scanned copy of documents/letter in company's letter head/pad. However hard copies should be submitted in the office through post/ by hand. Details of correspondence shall be made as per 'Clause No.-31 of Instructions to Bidders (ITB)'.


