

2. Eligibility criteria for participation in tender:

- (i) All categories of intending Bidders who have satisfactorily completed at least one Civil work of executed value not less than Rs. 9.19 lakh in a single contract after 1st February, 2015 under the authority of State/Central Government, State/Central Government Undertaking, Statutory Bodies constituted under the statute of Central/State Government. Valid copies of Work Orders, Completion Certificates indicating Estimated Amount, Value of work-done, Date of completion of the work and detail communication address of the client should be submitted by the Bidder (Original may have to be produced for verification). Completion Certificate from the concerned Executive Engineer/District




Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential.

- (ii) All categories of intending Bidders shall have to submit valid copies of GSTIN registration certificate and allied documents, Professional Tax (PT) deposit challans for last six months, E.P.F. Registration Certificate, ESI registration certificate (for ESI coverage areas only), PAN Card and Income Tax Return Acknowledgement for Assessment Year 2019-20, 2018-19, 2017-18, Trade License in respect of the prospective bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License), Ltd. Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License).
- (iii) Neither prospective Bidder nor any of the constituent partners had been barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertaking/ Enterprise etc during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (a declaration in this respect has to be furnished by the prospective bidders).
- (iv) The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (a declaration in this respect has to be furnished by the prospective bidders).
- (v) No conditional / Incomplete Tender will be accepted under any circumstances.
3. Intending bidders may visit the site giving prior intimation to the office before submission of tender.
4. Tender documents will not be issued/ received by post.
5. **Tender Fee:** To collect the Tender Documents, intending bidders shall have to pay Rs. 2183/- (Rupees two thousand one hundred and eighty three only) as Tender Fee (non-refundable) inclusive of GST of Rs. 333/-, payable either through A/C Payee Bank draft/Banker's Cheque of any Nationalised/Commercial Bank in India drawn in favour of "WEST BENGAL STATE ELECTRICITY DISTRIBUTION COMPANY LIMITED" payable at Siliguri or by way of payment in cash at the office of the undersigned.
