1. Techno-Commercial Requirements of the Bidder (Must Conditions):

- A. Experience of having successfully completed similar works during last 10 (ten) years with fulfillment of any of the following criteria:
- 3 similar completed works, each costing not less than 40% of the estimated value or,
 - 2 similar completed works, each costing not less than 50% of the estimated value or,
 - One similar completed work, costing not less than 80% of the estimated value.
- B. Valid PAN, EPF code no., GST registration no., current Professional tax payment certificate.
- C. Average annual turnover during last 3 years not less than 30% of the estimated value.
- D. Working capital in the year preceding the year of bid submission not less than 30% of the estimated value (to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).
- E. Submission of annual audited financial report for last 3 years and copy of IT returns with related enclosures (Form 3CA & Form 3CB) for last 5 years.

Tender cost and earnest money shall have to be deposited offline to the above office by Banker's Cheque/Demand Draft/Pay Order issued from any scheduled Bank in favour of the "West Bengal State Electricity Distribution Company Limited" payable at Kolkata and also to be documented through e-filling. Earnest money may also be submitted through Bank Guarantee, in the manner detailed in relevant clause of this bid document. Bids without appropriate earnest money deposit and tender cost shall be rejected.

The earnest money & tender cost will be accompanied by hard copy of the filled-in 'Mandate Form by Vendor for RTGS/NEFT Payments' with self-attested photocopy of the bidder's PAN Card, GSTIN document and one cancelled cheque.
