    - b) 2 similar completed works, each costing not less than 50% of the estimated value or,
    - c) One similar completed work, costing not less than 80% of the estimated value.
  - B) Valid PAN, EPF code no., GST registration no., current Professional tax payment certificate. copy of IT returns for last three years.
- 2. For e-filling of bids, intending bidder shall download the bid documents from the website https://wbtenders.gov.in directly with the help of Digital Signature Certificate. Both Technocommercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule below.

Tender cost and earnest money shall have to be deposited offline to the above office by Banker's Cheque /Demand Draft/Pay Order issued from any scheduled Bank in favour of the "West Bengal State Electricity Distribution Company Limited" payable at Kolkata and also to be documented through e-filling. Bids without appropriate earnest money deposit and tender cost shall be rejected.
