### **NOTICE INVITING e-TENDER**

Tenders are invited by the Additional Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., P.O. Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from Original Equipment Manufacturer for the following work:

- 1. Name of the work:** Design, engineering, manufacture, testing at manufacturer's works, supply, delivery of 6 Nos., 3 ph, Copper wound, oil immersed 33KV Earthing transformers as per desired specification mentioned in technical specification for Teesta Canal Fall Hydel Project under WBSEDCL.
- 2. Price Basis:** The Price shall be quoted on FOR TCFHP Store site basis including all charges towards freight & transit insurance, packing & forwarding etc. GST will be paid extra as per actual. The quoted prices shall remain FIRM during the currency of the contract.
- 3. Earnest Money Deposit:** ₹ 3,00,000/- (Rupees Three Lakh only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. Details regarding the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.
- 4. Eligibility Criteria:**
  - i) The bidder must be the original manufacturer of the same or higher rated voltage class Zig-zag Earthing Transformer and the bidder must have delivered same or higher rated voltage class Zig-zag Earthing Transformer in any Indian Power Utilities.
  - ii) The same or higher rated voltage class Zig-zag Earthing Transformer must be successfully commissioned in any Indian Power Utilities within last 10 (ten) years as on date of NIT.
  - iii) The tendered/offered transformer should be Type Tested as per relevant latest IS/IEC from Govt. recognized/NABL accredited Test Laboratory. Complete Type Test Report shall have to be submitted along with the offered bid. The bidder who has no Type Test Report, shall have to submit one undertaking along with their offer declaring that before offering inspection call they will perform the above Type Test free of cost without affecting the delivery schedule of the tender.

- iv) Documentary evidence regarding category of the manufacturer (Micro/ Small/ Medium/ Large) like Registration Certificate issued by SSI/ NSIC/ Directorate of Industries etc.
  - v) List of purchase order references for similar supplies in the past five (5) years with copies of un-priced/priced purchase orders and execution status of each order supported by duly acknowledged delivery challans or excise duty gate passes or, client's certificate.
  - vi) Performance Certificates from the user for successful operation of similar equipment.
  - vii) Valid GST Registration certificate and GSTR3B or Annual return- GSTR9 for last two years.
  - viii) PAN Card.
  - ix) IT Return for the last three years.
5. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in> and should be submitted online on or before as per the 'Date & Time Schedule'.
6. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
7. The offer against tender should remain valid for a minimum period of 120 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
8. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in <http://www.wbseedcl.in> website.

14. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
15. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
16. Conditional / Incomplete tender will not be accepted under any circumstances.
17. The intending Bidders are required to quote the rate online at [www.wbtenders.gov.in](http://www.wbtenders.gov.in)
18. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
19. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
20. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria.
