NOTICE INVITING e-TENDER

Tenders are invited by the Additional Chief Engineer and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., P.O. Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from **Original Equipment Manufacturer (OEM) only** for the following work:

- 1. Name of the work:** Supply, delivery, Installation, Testing and Commissioning of Microprocessor based numerical relay and electromechanical/static relay for retrofitting work at 6 nos. control relay panels of the 3 x 50 MVA, 1 x 31.5 MVA & 2 x 20 MVA, 132/33 kV Grade Power Transformer installed at different Power Station under TCFHP, WBSEDCL.
- 2. Earnest Money Deposit: ₹ 2,14,421/-** (Rupees Two Lakh Fourteen Thousand Four Hundred Twenty One only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. Details regarding the same are narrated in "B. Instructions to the Bidders". As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.
- 3. Eligibility Criteria:**
 - i) Bidder having experience of successfully completed similar work in WBSEDCL / WBSETCL / WBPCL / NHPC/ Power Grid / NTPC or any other power utility in India during last 07 years. Copy of at least one order should be uploaded.
 - ii) Confirmation regarding availability of in-house inspection /testing facilities or access through other government approved agencies for performing testing.
 - iii) Client Certificate needs to be furnished showing that Proposed equipment are under satisfactory operation for not less than 02 (Two) year as on date of Bid submission.
 - iv) Bidder must have registered office in India and Service Centre to provide service viz. erection, testing, commissioning and after sales services during and after guarantee period.
 - v) Bidder must assure to facilitate after sales service and spare availability for at least 15 years from the date of submission of bid.



- vi) Copies of Type test certificate of the equipment/Materials included in the scope of supply as per relevant IS/IEC. The issuance date of type tests should be within 05 years from the issuance date of this NIT.
- vii) Valid GST Registration certificate and GSTR3B or Annual return- GSTR9 for last two years.
- viii) PAN Card.
- ix) Audited annual Accounts of the Company for the last 03 (three) years (in case of companies) or IT return duly acknowledged by the Income tax department for the last 03 (three) years (in case of bidders other than company)
4. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in> and should be submitted online on or before as per the 'Date &Time Schedule'.
5. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
6. The offer against tender should remain valid for a minimum period of 120 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
7. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in <http://www.wbsedcl.in> website.

13. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
14. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
15. Conditional / Incomplete tender will not be accepted under any circumstances.
16. The intending Bidders are required to quote the rate online at www.wbtenders.gov.in
17. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
18. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
19. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
20. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
