5. Eligibility criteria for participation in the tender:

- Experienced & resourceful manufacturers/suppliers/Distributors undertaking Organizations, Govt. enterprises of WBSEDCL/ others power utilities/Govt./Semi Govt. Departments/Govt. undertaking Organization /Govt. Enterprises who have successfully completed similar nature of work having value not less 50%(fifty percent) of the estimated cost in a single contract during last 5 (five) years.
6. All intending bidders are required to produce value copies of GST Registration, professional Tax (PT) deposited challan for the last month, copy of IT return for last three financial years ie 2019-20, 2020-21, 2021-2022 assessment year, PAN, Documents in support of Credential such as copy of orders and completion certificates (To be documented through e- filling).
 7. No mobilization/secured advance will be allowed.
 8. Constructional Labor welfare Cases @ 1% (One percent) of cost of construction will be deducted from every Bill. All others statutory levy/Cases as applicable will have to be borne by the contractor & the rate in the schedule of rates are inclusive of all such taxes and cases as stated above. The estimated cost is exclusive of GST. GST will be admissible as per prevailing rates and rules in force.
 9. Bids shall remain valid for a period not less than 18 (one hundred eighty) days after date of financial bid opening of tender bid valid for a shorter period shall be rejected by the Tender inviting authority as non- responsive. If the tender withdraws the bid before the period of bid. 10. The bidder shall select the tender to bid and initiate payment of EMD. Following payment options are available for paying EMD amount through online mode:
 - a) Net banking through payment Gateway.
 - b) RTGS/NEFT payment: On selection of RTGS/NEFT as the payment mode. The e procurement portal will show a pre filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre filled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
 - c) Submission of EMD through BG: for submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in the tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT.
11. The bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing bid and entering into an agreement for the work/ works as mentioned in the NIT, before submitting offer with full satisfaction. The costs for visiting the working site shall be at the bidder's own expense.
12. The intending bidders shall clearly understand that whatever may be the outcome of the present invitation of the bid, on cost of bidding shall be reimbursable by the tender inviting authority. The tender inviting authority reserves the right to accept or reject any/ all offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by the bidder at the stage of bidder.
13. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in Instruction to bidders stated in section- A' before tendering the bids.
14. Work Order & payment of work will be dependent on availability of fund. Intending bidders may consider these criteria during submission of tender quoting their rate through online.
15. No conditional bid/ Incomplete tender will be accepted under any circumstances.
16. The intending bidders are required to quote the rate in the BOQ (as space provide) over online considering that no escalation and/ or price adjustment will be allowed by the department under any circumstances.

At any stage during scrutiny, if it is found that the credential or any other papers which the bidder uploaded during bidding process found incorrect/manufactured/ fabricated, that bid will be considered a nonresponsive and will be outright rejected with forfeiture of Earnest Money and action will be taken as per stipulation of IT Rules in force.

19. Lowest evaluated bidder (Item wise) will be determined as per rate quoted against each item.

Lowest bidder has to submit a sample of the material for approval within 07 (seven) days after opening of the tender. Placement of order is subject to approval of the sample by Divisional sample approval committee.
