- a) **Price:** FOR Massanjore Hydel Power Station basis, Price should be firm including all incidentals charge likes delivery charges, cess, Taxes & duties. GST will be paid extra if applicable.
- b) **Delivery Period:** Within 20 days from the date of placement of order.
- c) **Place of delivery:** The material will be delivered by you at Massanjore Hydel Power Station, District- Dumka , Jharkhand-814144.
- d) **Freight & Insurance:** In the scope of supplier.
- e) **Paying Authority:** The Additional General Manager (F&A), PPSPHQ, WBSEDCL, Vidyut Bhavan, Kol-700091

- k) **Offer Validity:** The offer must remain valid for 60 (sixty) days from the date of opening of the offer.
- l) **Warranty Period:** 12 (Twelve) months from the date of successful completion of the job. Warranty certificate shall be submitted by you along with supply of materials. Materials as offered should be replaced free of cost if any defects found within the aforesaid warranty period.
- m) **Liquidated Damages:** Liquidated damages for delay in delivery @ 0.5 % of the value of the materials delivered beyond the schedule delivery period for each week of delay or part thereof subject to maximum of 10% of the contract price will be deducted from supplier.
- n) **Legal Jurisdiction:** If any dispute or difference arises with respect to quality / quantity of the equipment / material pertaining to this order or any other terms and conditions of the order including its execution, such dispute / difference shall be subject to settlement at Kolkata High Court.
- o) Total Lowest valid rate should normally be accepted. However, the tender accepting Authority does not bind himself to do so and reserves the right to reject any or all the tenders, for valid reasons which are not liable to express to the Tenderers. WBSEDCL reserves its right to curtail any parts of the scope of delivery for its financial interest.
- p) Tender papers are not transferable.

- r) **Risk Purchase clause :** On cancelation of the contact in full or in part, the WBSEDCL shall determine what amount, if any, is recoverable from the contractor for completion of the work or part of the work or in case the work or part of the work is not to be completed, the loss or damaged suffered by WBSEDCL. In determining the amount, credit shall be given to the contractor for the



value of the work executed by him up to the time of cancelation, the value of contractor's materials taken over and incorporated in the work and use of plant and machinery belonging to the contractor. Any excess expenditure incurred or to be incurred by WBSEDCL in completing the work or part of the work or the excess loss or damages suffered or may be suffered by WBSEDCL as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to WBSEDCL in law be recovered from any moneys due to you on any account, and if such moneys are not sufficient, you shall be called upon in writing and shall be liable to pay the same within 30 days.


- s) **Purchase Order/Work order:** WBSEDCL will communicate acceptance of tender to the successful bidder by a Purchase /work Order. The successful tender shall communicate the acceptance of the purchase/work order within a specific period to be mentioned on the order.
- t) **Cancellation / Termination of Order:** The time period for effecting complete supply of the above materials/equipment as indicated through the delivery schedule as given in term (a) shall have to be treated as the essence of the contract. The Company reserves the right to repudiate the contract if the above period is not strictly adhered to. In the event of failure in effecting the desired supply and delivery of the above equipment/materials within above stipulated due date as incorporated through the term (a), the above order may be cancelled on submission of necessary notice in this regard and fresh order may be placed on the next higher bidder or on any other bidder, as a result of which the extra cost thus liable to be incurred shall be realized from the original supplier's / service provider pending bills which may be lying with the WBSEDCL.
