SCOPE OF WORK: -

- 2. TECHNICAL ELIGIBILITY CRITERIA OF THE BIDDER: The bidder must have successfully completed similar nature of work. Similar nature of works during last seven years subject to fulfillment of the following criteria:
 - Three similar completed works each of the contracts comprising of executed value not less than the agreement than the amount equal to 40 % of the estimated cost i.e Rs. 3,72,678.00
