Price: The price is to be quoted as per schedule and should be net and firm inclusive of all incidental charges. The Provision of taxes & duties if any shall be governed by prevailing Govt. rules.

- 3. **Delivery & Demonstration:** The materials have to be delivered and demonstrated to the person of all the sites within 30 (Thiry) days from the date of issuance of work order.
- 4. **Liquidated Damage:** In the event of delay, a penalty will be imposed @ ½% per week or part thereof subject to maximum 10% of the ordered value which will be deducted from the bill.

5. Tools & tackles: The agency should arrange all tools & tackles required to execute the job.

6. **Payment:** 100% payment will be made after satisfactory completion of the work through A/c. payee cheque on S.B.I., Kurseong Branch, Kurseong against submission of bill, Test certificate and Guarantee certificate in triplicate to the controlling officer.

7. **Defective Materials:** If in the opinion of the Controlling Officer, any of the materials brought to the site for use are not of the quality of kind specified in the contract and /or are unfit for the works, he shall be at liberty to order the removal of the said materials and the contractor shall remove the same within 24 (Twenty four) hours after notice has been given to him and if he fails to remove them within the time, the Controlling Officer may cause them to be removed anywhere at the risk of the Contractor and any cost incurred in doing so shall be deducted from the dues to the contractor under the contract.

8. Clearing site on completion: On Completion of the work the Contractor shall clear away and remove from the site all constructional plant, surplus materials, rubbish and temporary work of every kind and leave the whole of the site and work clean and in good and tidy condition to the satisfaction of the Controlling Officer/ Engineer-in-charge.

9. **Safety of Materials**: The agency will be held responsible for any loss, damage caused to the material while carrying out the job and shall be liable to pay the amount of loss to be determined by joint inspection conducted by the representative of the store or Technical personnel of the department and the representative of the contractor.

10. The contractor shall be liable against all loss, expenses or claims in connection with the accident or injury to any labour employee during execution of the work.
