# **SECTION: I INSTRUCTION TO BIDDER (IB)**

**IB.1.** West Bengal State Electricity Distribution Company Limited herein after referred to as WBSEDCL invites **limited e-tenders** for implementation of **two numbers (2)** of **Internet Lease Line connection of 200 Mbps (1:1) with Anti DDOS service (1 Gbps)** for Data Center ,Rajarhat **by two different Vendors** (Address -Street Number 41, beside 33/11KV Substation, AF Block, Action Area I, Newtown, West Bengal 700163) as per detail "Scope of Work" and other terms and conditions furnished in the different clauses of the bid document.

Tender is invited by the Chief Engineer, IT&C Cell, 3rd Floor, 'D'-Block, Vidyut Bhavan, Bidhannagar, Block-DJ, Sector-II, Kolkata 700091 through electronic tendering (e-tendering).

Bidders having optical fiber and link infrastructure present at Data Center, Rajarhat are invited to participate in the tender by logging in to the website <a href="http://wbtenders.gov.in">http://wbtenders.gov.in</a>.

### IB.2. Eligibility of Bidders:

# Following are the credentials for eligibility of Bidders:

- **IB.2.1.** The Bidder should be a Class A ISP license/ULD license holder issued by Government of India and the bidder should have acquired valid NLD and ISP License from DOT.
- **IB.2.2.** The Bidder must have optical fiber/wireless network laid out at Data Center, Rajarhat and with link infrastructure device within Data Center which must be in operation.
- **IB.2.3.** The bidder should not have been blacklisted from any Govt. organization across India in last three calendar years and undertaking in this regard shall be provided by the authorized signatory of the bidder. During contract period if the undertaking submitted by the vendor is found to be false, the order issued on vendor shall be terminated with the forfeiture of the BG. (an undertaking letter to be provided)
- **IB.2.4.** If the bidder is a subsidiary or if the bidder's name has changed within the last 5 years, the credentials of the parent company or firm will be considered for the prior period.
- **IB.3. Selection Criteria-** In this tender, which involves parties competing for two internet lease lines, the following conditions will apply:
  - **IB.3.1.** It is imperative for the company to maintain two different networks for uninterrupted data connectivity and as such company maintains redundancy of links. Hence two different bidders are to be selected.
  - **IB.3.2.** Lease Line-1 link is expiring on 23-11-2024 and Lease Line-2 is expiring on 30-11-2024.
  - **IB.3.3.** In line with the WBSEDCL's requirements, if a bidder becomes the lowest bidder (L1) for Lease Line 1, said bidder may not be considered for the Lease Line 2. The next successful bidder will be awarded Link 2 at the rate quoted by L1.
  - **IB.3.4.** If bidders fail to provide the connectivity or is not considered due to above mentioned reasons then next successful bidders may be selected at the rate quoted by L1.

#### **IB.4.** Responsibility of Bidders:

- **IB.4.1.** It shall be the sole responsibility of Bidders to determine and to satisfy themselves by such means as they consider necessary or desirable for all matters pertaining to this contract including, in particular, all factors that may affect the cost, duration and execution of the work.
- **IB.4.2.** It must be understood and agreed that such factors have properly been investigated

and considered while submitting the bid. Any claim, whatsoever, including those for financial adjustments to the contract, once awarded under these documents will not be entertained by WBSEDCL. Neither any change in time schedule of the contract nor any financial adjustments, arising thereof, shall be permitted by WBSEDCL, which are based on the lack of such clear information of its effect.

- **IB.4.3.** The bid shall include all the information as per bid document. Submitted documents need to be specific as per requirements; irrelevant documents shall not be uploaded by bidder.
- **IB.4.4.** The bidder shall bear all the costs associated with the preparation and submission of bid and WBSEDCL in no case shall be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- **IB.4.5.** In order to avoid any problem arising out of network error or server error, bidders are advised to submit the bid, well in advance of the last date and time of submission of the bid.

#### **IB.5.** Conflict of Interest:

- **IB.5.1.** The Bidder shall not have a Conflict of Interest that may affect the Tendering Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Bid Security of the bidder shall be forfeited for the time; cost and effort of the Authority including consideration of such Bidder's Proposal, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.
- **IB.5.2.** Any Bidder found to have a conflict of Interest if his near relative is posted as an employee/officer in any capacity in WBSEDCL, who is associated with the Tender Inviting Authority.
- **IB.5.3.** Any Bidder found to have a Conflict of Interest if any employee of the bidding firm/company has or develops a financial or other interest with any employee/officer of WBSEDCL associated with the Tender Inviting Authority during execution of the contract.
- **IB.5.4.** Any Bidder has a relationship with another Bidder/Bidders, directly or through common third parties, that puts them in a position to have access to each-others information about, or to influence the Tendering Process of either or each of the Bidder.

#### **IB.6.** Formation of cartel & penal Measures:

Any evidence of unfair trade practices, including overcharging, price fixing, cartelization etc. as defined in various statutes, will automatically disqualify the parties. Repeated occurrence of such evidence of above tenderers may also be viewed seriously by the WBSEDCL authority and penal measures as deemed fit would be imposed on such tenderers.

**IB.8.** If any 'Strike' or 'Holiday, falls on any of the scheduled date, then the next working day (between mentioned working hours) shall be considered as scheduled date and schedule time.

#### **IB.9.** Pre Bid Discussion:

- **IB.9.1.** Pre-bid discussion will be held at WBSEDCL as per schedule indicated in **"Key Dates Clause"** above to clarify the queries, if any, from the vendors in respect of tender. Selected vendors who shall purchase the Bid may participate (maximum two persons) in the said meeting for any such clarification.
- **IB.9.2.** Relevant queries in soft copy EXCEL format as per ANNEXURE-VII must be sent on or before the last date for Pre Bid query submission as mentioned above. Mail must be sent to- **network.itcell@wbsedcl.in** with copy to **ceit@wbsedcl.in**.
- **IB.9.3.** Non-attendance at the pre bid discussion will not be a cause for disqualification of the bidders.
- **IB.10. Amendment / Addenda of Bidding Documents:** At any time, prior to the deadline of submission of Bid, WBSEDCL may, for any reason, modify the Bidding Documents by issuing Addenda / Amendments and the same will be uploaded in the website ( <a href="http://wbtenders.gov.in">http://wbtenders.gov.in</a>) only in due time. WBSEDCL shall not have any obligation to inform the vendor through any other mode of communication.
- **IB.11.** Language of the Bid: All correspondences and documents relating to the bid, exchanged by the bidder and WBSEDCL, shall be in English Language only.
- **IB.12. Period of validity of Bid:** The bid shall <u>remain valid for acceptance up to 180 (One hundred eighty) days from the date of opening of tender.</u> WBSEDCL may request to extend Validity of the bid beyond 180 (One hundred eighty) days if required so, without any change in offer.

#### **IB.13.** Earnest money [Bid Guarantee]:

**IB.13.1.** The bidder desirous of taking part in a tender invited by Offices of WBSEDCL shall login to the e-Procurement portal of Government of West Bengal

- https://wbtenders.gov.in using his login Id and password.
- **IB.13.2.** The bidder shall select the tender to bid and initiate payment of EMD of Rs. **26,250/-** (Twenty Six Thousand Two hundred and Fifty Rupees Only). Following payment options are available for paying EMD amount through online mode:
- **IB.13.3.** Net-banking through Payment Gateway.
- **IB.13.4.** RTGS/ NEFT Payment: On selection of RTGS / NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/ NEFT transaction. The bidder will print the challan and use the pre- filled information to make RTGS / NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e Procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/ NEFT process to be completed.
- **IB.13.5.** Submission of EMD through BG: For submission of EMD in the form of BG issued by any Scheduled Bank of RBI, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT. The Bank Guarantee shall be submitted as per format in ANNEXURE-V and shall remain valid initially for a period of 180 (one hundred eighty) days from the date of opening of bid document mentioned elsewhere in this NIT.
- **IB.13.6.** EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. Partial payment through online mode and remaining submission through BG is not allowed.

#### **IB.13.7.** General Instructions for Online Payment:

- **IB.13.7.1.** The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.
- **IB.13.7.2.** Status of NEFT/ RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NEFT/ RTGS mode shall make payment well before 24 Hrs. to avoid any complicacy.
- **IB.13.7.3.** In case actual EMD amount as per NIT is more than the one shown in Etender Portal, bidders will have to opt for NEFT/ RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/ RTGS mode (challan mode).
- **IB.13.7.4.** The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/ c from which the payment of EMD has been initiated.

#### **IB.13.8.** Refund/Settlement of EMD Amount:

- **IB.13.8.1.** For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- **IB.13.8.2.** The Bid Guarantee of unsuccessful bidders, if submitted through Bank Guarantee, will be returned against their written claim, to the Chief Engineer (IT&C Cell), WBSEDCL, giving the reference to the NIT, date of tender, amount and mode of Earnest Money deposited all in a complete form, after placement of order on the successful bidder/bidders.
- **IB.13.8.3.** For successful bid(s), EMD will be refunded from WBSEDCL authority after

completion of tendering process and submission of Performance Bank Guarantee as per respective clauses in NIT. Successful bidder shall submit one letter addressed to Chief Engineer (IT&C Cell), WBSEDCL giving reference of NIT, date of tender, amount, mode of earnest money deposited and details of Performance Guarantee for requesting refund/return of EMD amount or bank guarantee, as applicable.

- **IB.13.8.4.** The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
- **IB.13.8.5.** For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033-40267512/13 since payment gateway facility used by E tender portal is maintained by ICICI.
- **IB.13.9.** No interest shall be payable by WBSEDCL on the above Bid Guarantee.
- **IB.13.10.** The Bid Guarantee shall be forfeited for any of the following reasons:
  - **IB.13.10.1.** If during the period of bid validity, the bidder withdraws or modifies the bid in part or as a whole.
  - **IB.13.10.2.** If the successful Bidder/ Bidders fails/fail to accept the order unconditionally as per "Acceptance of Order" clause of bid document or fails/fail to furnish the contract performance guarantee as stipulated in PBG clause of bid document.
  - **IB.13.10.3.** If the successful bidder / bidders fails to extend the validity period of EMD as per **"Earnest Money" Clause** of bid document.
  - **IB.13.10.4.** If any cartel is formed by the tenderer in their quotation.

## **IB.14. Submission of Bid:**

#### IB.14.1. Bids shall be submitted as under:

Tenders are to be submitted online through the website https://wbtenders.gov.in. All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for, in the tender, through the above website within the stipulated date and time as given in the Tender. Tenders are to be submitted in two folders - one is Technical Proposal and the other is Financial Proposal. The tenderer shall carefully go through the documents and prepare the required documents and upload the scanned documents in the designated locations of Technical Bid.

The bidder needs to download the Forms / Annexures, fill up the particulars in the designated Cell and upload the same in the designated location of Technical Bid.

#### **IB.14.2.** Technical Proposal

The Technical Proposal shall contain scanned copies and/or declarations in the following standardized formats in covers (folders) and the same needs to be uploaded. The scanned documents may be joined and indexed with page numbering having contents description in the first page.

- a) Original Bid proposal ANNEXURE-I.
- **b) Bidder Details** in format as prescribed in Annexure-II of NIT. It shall be filled up properly by the bidder. It will be treated as reference for technical evaluation of bid. Incomplete or improperly submitted bid detail may lead to rejection of bid.
- **c)** An undertaking letter that all the pages of Tender document, annexures along with any Addenda/Corrigendum have been read and agreed to.
- **d)** Scanned copy of Bank Guarantee (BG) towards EMD in format as prescribed in Annexure-V of NIT, in favor of WBSEDCL payable at Kolkata from any scheduled Bank of RBI. Issue date of BG shall be after NIT publication date. This clause will be applicable only for cases where Earnest Money Deposit (EMD) has been submitted through BG.

### **IB.14.3.** Financial Proposal

The financial proposal shall contain **Bill of Quantity (BOQ)** as per Annexure III. Bidder has to quote the rate online in space marked for quoting rate in BOQ. (Only downloaded copies of the above document should be virus scanned, digitally signed and uploaded by the bidder).

- Rate quoted for 200 Mbps link in BOQ will only be the selection criteria.
- Rate quoted in Annexure XI for 500 Mbps and 1 Gbps will not be considered for selection and are being collected in case of any upgradation that may be required during order period.

# IB.15. Submission of original copies of documents of Earnest Money Deposit if not done in online mode:

- **IB.15.1. Mode of Payment**: EMD to be submitted as mentioned above.

- **IB.15.3.** Time of Submission- The original copies of BG towards EMD shall be submitted in a sealed envelope in the office as stated above within the date and time as specified in the NIT (**Mention the NIT number and Tender Notice Number and Name/Description on envelop).** If the bidder fails to submit the original copies within the due date and time his tender will not be opened and his bid will stand rejected.
- **IB.15.4.** Conditional and incomplete tenders are liable to summary rejection.

#### **IB.16.** Opening and evaluation of tender

- **IB.16.1.** Technical proposals will be opened by the Tender Inviting Authority or his authorized representative electronically from the website stated above, using their Digital Signature Certificate.
- **IB.16.2.** Technical proposals for those tenderers whose original copies of BG towards EMD (in case of submitted in offline mode) have been received will only be evaluated. Proposals corresponding to which original copy of BG towards EMD has not been received, will not be opened and will stand evaluated.

- **IB.16.3.** The bidder shall not take any commercial deviation from the stipulation of Bid document. If the bidder takes any commercial deviation, his Bid may be liable for rejection.
- **IB.16.4.** The summary list of bidders, whose bids will be found techno-commercially eligible, will be uploaded in the web portals. Date of opening of financial bid will be intimated to the techno-commercially qualified tenderers.

### IB.17. Opening of financial proposal (price bids).

- **IB.17.1.** Financial proposals submitted by the tenderers in the prescribed format of BOQ (ANNEXURE-III) and declared techno-commercially eligible, will be opened electronically by the Tender Inviting Authority from the web portal stated above on the prescribed date.
- **IB.17.2.** No deviation in any form in the price-bid sheet is acceptable.
- **IB.17.3.** The encrypted copies will be decrypted and evaluated online.
- **IB.17.4.** After opening of the financial proposal the preliminary summary result containing inter-alia, name of bidders and the rates quoted by them will be uploaded.
- **IB.17.5.** The Tender Accepting Authority may ask any of the tenderers to submit analysis to justify the rate quoted by that tenderer.
- **IB.17.6.** For any discrepancy in the amount of figures and words, the quoted amount in figure will prevail.

# **IB.18.** Evaluation and Comparison of Bids (Price bids)

- **IB.18.1.** On examination of documents submitted under different covers WBSEDCL will evaluate and compare the bids determined to be substantially responsive at each step.
- **IB.18.2.** The bidder shall indicate the above prices clearly in the respective price schedule.
- **IB.18.3.** If Rebate / Discount are offered, the overall discount on ex-works price only in percentage is to be given. The financial impact of Rebate / Discount shall also be brought out in the Summary Price Bid.
- **IB.18.4.** Conditional Rebate / Discount, if any, offered by any Bidder shall be outside the purview of commercial terms & conditions & shall not be considered during Bid evaluation.
- **IB.18.5.** Evaluation of bid shall be made on the total price of all the items, clubbed together. This will however not encroaches the right of WBSEDCL to go into further processes for item wise evaluation, if required. Total price shall be calculated on the basis of quantity indicated in the NIT.
- **IB.18.6.** No separate packing & forwarding charge will be paid extra. Any variation, up or down, in taxes & duties or any new levy introduced subsequent to bid opening will not be considered for comparison of bids.
- **IB.18.7.** All prices should be given item wise, although evaluation will be made on total price of all items. Incomplete or partial quotation will not be accepted and shall be liable to be rejected.

- **IB.18.8.** Price should be quoted in the BoQ as per format. No deviation in any form in the BoQ is acceptable. The quoted price shall remain firm throughout the period of the contract and no adjustment shall be made to the contract price in respect of rise or fall in cost of Installation & Commissioning Charge.
- **IB.19. Execution Period-**The basic consideration and the essence of the Contract shall be in strict adherence to the time schedule as it will be specified in the LoA (Letter of Award) to be issued from WBSEDCL. The entire activity as per scope of work shall be completed by you within **7** (**seven**) **days** from zero date. Date of issuance of LoA (Letter of Award) shall be considered as zero date. The entire work need to be completed on turnkey basis. Letter of Intent (LOI) may be given earlier so that necessary processing could be done from vendor end.

# **IB.20.** Taxes, Duties and other levies:

No custom duty will be paid by WBSEDCL. Goods Service Tax (GST) applicable shall be paid extra.

**Statutory Obligations:** Statutory obligations as per law of the land are to be complied.

- **IB.20.1.** IB.22.1 Compliance of Labour Laws: The bidder shall comply with all the statutory labour laws to protect the employees/workers engaged by them.
- **IB.20.2.** IB.22.2 Statutory obligations as per law of land are to be complied.
- **IB.21. Period of Contract** Period of contract shall be up to 31.03.2026 from the date of placement of order (for both ILL1 and ILL2) and WBSEDCL may renew the period of contract for further two years in-continuation and so on depending upon the performance of previous years of the bidder at the same terms and conditions of the Letter of Award (LOA) placed on successful bidder which shall be accepted by the bidder without imposing any conditions.
- **IB.22. Issue of LOA:** WBSEDCL will award the contract to the successful bidder whose bid has been determined to substantially responsive and has been determined the lowest evaluated bid, provided further that the bidder is determined to be qualified to perform the contract satisfactorily. WBSEDCL shall be the sole judge in this regard.
- **IB.23. Acceptance of LOA:** The successful bidder shall submit written unconditional acceptance of LOA within 7 (Seven) days from date of issuance of the same. Submission of conditional acceptance of LOA shall be treated as non-compliance of this clause.
- **IB.24. Right to reject Bids:** WBSEDCL reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders the reason for WBSEDCL's action.
- **IB.25. Representative of Vendors:** The successful vendor is required to nominate officers, exclusively for this project from commencement to completion as 1) Nodal Officer for scheme & 2) an overall Head Officer, with whom WBSEDCL will contact on all matters related to this project. The vendor has to specifically furnish to WBSEDCL, the name, designation, mobile no, office & residential phone no of such persons.
- **IB.26. Mandatory Condition:** The bidder shall provide documentary evidence satisfactory & acceptable to WBSEDCL to establish that they have the requisite credential, capability and experience to handle the contract and meet requirements. The bidders shall provide any other documents as and when required by WBSEDCL related to tender.

- **IB.27. Settlement of Disputes:** In case of any dispute arising out the contract, the same should be settled through meeting between the WBSEDCL and the contracting agency at the appropriate level. The necessary judicial affairs and/or Court Case shall be exclusively within the jurisdiction of High Court at Kolkata only.

- **IB.29.1.** The successful vendor is required to nominate one officer exclusively for this project from commencement to completion as a Nodal Officer to be stationed at Kolkata, with whom WBSEDCL will contact on all matters related to this order.
- **IB.29.2.** The vendor has to specifically furnish to WBSEDCL, the name, designation, Telephone no. including mobile no., email address of such person.

# SECTION: II Scope of Work [SW]

To provide Internet access at gateway level through 200 Mpbs 1:1 uncompressed symmetric Internet Lease Line at Vidyut Bhawan along with **minimum of 8 static IPv4** addresses. If required IPv6 pool to be provided.

The project shall be carried out in the following manner: -

## SW.1. Scope of Work: The project shall be on turnkey basis.

#### **SW.1.1.** Internet connectivity at Corporate Office:

- **SW.1.1.1.** The terminating link should provide 200 Mbps leased internet connection. Contention ration should be 1:1.
- **SW.1.1.2.** The lease line should be of Fiber optic with ring Topology to provide redundancy. Last mile link topology diagram to be submitted.
- **SW.1.1.3.** Successful bidder should provide the internet over their own or arranged redundant last mile.
- **SW.1.1.4.** Successful Bidders endpoint equipment's should be scalable to support bandwidth at least up to 1Gbps.
- **SW.1.1.5.** Ring Topology to be used for last mile connectivity from PoP level.
- SW.1.1.6. Successful Bidder should ensure that local loop provisioning does not violate regulations as laid by Government of India / TRAI in respect of such links / networks.
- SW.1.1.7. Successful bidder shall arrange the necessary way leave /ROW (Right of Way) in connection to the establishment of way of the link. WBSEDCL shall neither negotiate nor incur any additional charges towards obtaining way leave (ROW) permissions whatsoever.
- SW.1.1.8. Successful Bidders should provide all necessary equipment's for connectivity.
- SW.1.1.9. ISP shall provide dual handoff as the link is for DC
- **SW.1.1.10.** The Successful bidder shall provide necessary tool to monitor current and total data/bandwidth, dropped packets consumption in real-time.
- SW.1.1.11. The personnel assigned in this project should be aware of ISO 27001:2013/2022 requirements and must be aware of Information security requirements.

#### **SW.1.2.** Anti DDos service of ILL at Gateway level.

- SW.1.2.1. Bidder to provide Cloud based Volumetric DDoS detection and mitigation services along with the ILL. An undertaking mentioning start date of DDOS service to be provided along with Link & DDOS portal as mentioned below.
- **SW.1.2.2.** DDoS detection & mitigation should be of minimum 1 Gbps capacity for Volumetric attacks on link.
- **SW.1.2.3.** Service provider to mitigate both IPv4 and IPv6 IP pools.
- **SW.1.2.4.** Service provider to mitigate all kinds of volumetric attacks.
- **SW.1.2.5.** 24x7 real-time sampling and detection of anomalies through the regular and proactive capture of flow data at the aggregation layer of the network to build up-to-the-minute flow records for trend analysis and threat detection.
- **SW.1.2.6.** Solution should have machine-learning and behavioral-based algorithm to detect low and slow DDOS attack.
- **SW.1.2.7.** The Proposed solution must not modify MAC ,IP addresses or contents of passed frames and should not impact customer legitimate traffic.

- **SW.1.2.8.** The bidder must be able to mitigate as close to the source of the attacks to ensure minimal additional latency due to re—routing.
- **SW.1.2.9.** The solution should handle varying levels of traffic to accommodate potential DDoS attacks of different magnitudes with zero impact on assets under protection.
- **SW.1.2.10.** The bidder must mitigate all types of DDoS attacks originating from within India and/or outside India.
- SW.1.2.11. The proposed solution should have a mitigation mechanism to protect against zero-day DoS and DDoS attacks without manual intervention and response time should be minimal.
- **SW.1.2.12.** The proposed solution must have an updated threat feed that describes new malicious traffic (botnets, phishing).
- **SW.1.2.13.** The proposed solution must not have any limitations in handling the number of concurrent sessions for DDoS attack traffic.
- **SW.1.2.14.** Mitigation of DDoS attacks shall be seamless to the general end-user utilizing internet to/from the Customer.
- SW.1.2.15. Testing of service and baselining shall be undertaken after approval from WBSEDCL at least annually to validate the operation of DDoS mitigation services.

## **SW.1.3.** Portal for link and DDOS service monitoring -

- SW.1.3.1. In-depth live reporting and online user portal including usage, attacks, and protection related to DDOS must be made available. Also reports related to present bandwidth consumption report and DDOS related reports..
- SW.1.3.2. The bidders Portal should provide near real-time visibility into WBSEDCL network traffic and provide high, medium and low severity alerts identified through ongoing sampling and IP traffic and DDoS anomalies.
- **SW.1.3.3.** The portal must have view only mode with access to downloading of reports for at least 3 concurrent logins/3 different users.
- **SW.1.3.4.** Logs for minimum 3 months related to Link and DDOS traffic must be preserved and must be shared with WBSEDCL on requirement
- **SW.1.4.** The existing Router, Switch & LAN port will be used for holding the proposed Internet Connection.
- **SW.1.5.** Any reports as asked by government agencies/auditors related to IT security issues or incidents to be provided.
- **SW.1.6.** Call docket will be done to official mail id provided by bidder.
- **SW.1.7.** Rate for 500 Mbps and 1 Gbps to be provided (Annexure XI) which may be used if upgradation required during order period. The rates will not be used for selection and only 200 Mbps as in BOQ will be used for selection process.
- SW.2. Hand Over & Take Over of the System after Completion: Successful vendor shall hand over the entire system after successful trial-run. Vendor shall complete installation & commissioning (with successful trial-run), as a whole, as per Scope of Work before handing over the system to WBSEDCL. The concerned site office in charge will provide Commissioning certificate if all provisions are met satisfactorily by the vendor.

# **SECTION: III**

# **General Conditions of Contract [GCC]**

## **GCC.1. General Terms:**

- **GCC.1.1.** The entire work shall be executed on TURN KEY concept.
- **GCC.1.2.** Existing UPS power from UPS to IT equipment's will have to be taken from WBSEDCL end.
- **GCC.1.3.** The established link should be scalable up to 1 Gbps 1:1 at least.
- Any hardware like Mux/Modem which is required will be provided by successful bidder and it will be included in services. The hardware shall be property of the successful bidder and will be responsibility of the successful bidder. The hardware shall be maintained free of cost.
- **GCC.1.5.** A comprehensive fiber layout plan and DDOS mitigation plan has to be submitted at WBSEDCL's end.
- **GCC.1.6.** The WBSEDCL reserves the right to reject the contract if any deviation from tendered specifications is found in the service any point of time and the same is not rectified even after ticketing.
- **GCC.1.7.** The Bidder should submit system generated report of total uptime and availability / packet loss for monthly basis.
- **GCC.1.8.** The bidder shall ensure an uptime of 99.5% for the entire duration. Failing so will attract penalty as per Uptime Calculation & Penalty clause.
- **GCC.1.9.** The vendor has to provide onsite support, when required.
- **GCC.1.10.** Bidders shall also submit proposals of work methods and schedule, in sufficient detail to demonstrate the adequacy of the bidders' proposal to meet the technical specifications and the completion time.
- **GCC.1.11.** The bidder has to furnish all the information as required regarding their offer, along with declaration that it complies to clause of SW 1.2 to SW 1.3.
- **GCC.1.12.** The bidder shall satisfy WBSEDCL with his ability to complete the works positively within the stipulated time.
- **GCC.1.13.** All correspondence, documents and Bid, exchanged between the Bidder and WBSEDCL shall be written in English language. Failure to comply with this request may disqualify a bidder.
- **GCC.1.14.** The Company reserves the right, to reject any or all the tenders, at its discretion, without assigning any reason whatsoever.
- **GCC.2. Service Level Agreement (SLA):**This SLA describes the Service Levels applicable. Non-achievement of a Service Level may attract penalties, as set out in this SLA. The bidder shall sign SLA with WBSEDCL incorporating following parameters:

#### **SLA for link and DDOS uptime:**

The Actual Uptime on Link and Anti DDos service to be calculated in respective month and will be measured against total uptime hours 99.5%. If the downtime exceeds the total uptime hours following penalty in % will be applicable:

**Example:** In the Month of November total days is 30 and total down time in the same month in hours was 5 hours. In such case the Actual Uptime can be calculated as follows: Total hours in the month = 30 X 24 = 720 Actual Uptime Hours = 720 - 5 = 715 Actual Uptime % = (715/720) X  $100 \approx 99\%$ . Then 10% penalty to be deducted from both DDOS and link service charge.

**SLA for DDoS Mitigation**: The service provider will mitigate DDoS attacks in real-time from the start of the attack. A 15-minute rebate will be given to mitigate the attack in a month. If the attack is not mitigated within that 15 min (rebate time), the link will be considered down, and a downtime penalty, as specified in the table above, will be deducted from the DDoS service charge. The SLA will be applied to the ordered bandwidth of 1 Gbps only and not for any bandwidth exceeding this limit. A systemgenerated report from the vendor must be provided, and bandwidth consumption reports from our end will be used to calculate the SLA for the DDoS service. The vendor must provide a bandwidth consumption report monthly, and the SLA calculation will be done on a monthly basis.

**Example**: In the Month of November total days is 30 and total down time in the same month in hours was 5 hours 15 mins due to non-mitigation of DDOS attacks . In such case the Actual Uptime can be calculated as follows: Total hours in the month =  $30 \times 24 = 720$  Actual Uptime Hours = 720 - 5 = 715 Actual Uptime % =  $(715/720) \times 100 \approx 99\%$ . Then 10% penalty to be deducted from DDOS service charge only.

#### **SLA for Technical Parameters-**

If NSP (Network Service Provider) fails to meet the Technical Parameters for Latency / Packet loss, then the link would be treated as down. Calculations to be done as per SLA Rebate for downtime.

- 1. Throughput: 100% non-blocking [symmetric]
- 2. Latency: < 80ms Domestic and < 250ms International.
- 3. Packet Loss/Drop: < 0.5% .A packet loss more than 2% will be considered downtime while the link utilization is not full.

## gcc.3. Force Majeure:

- WBSEDCL shall be under no liability if the vendor is prevented from carrying out any of the vendor's obligations by reason of war, Invasion, act of foreign country, hostilities, riots, civil commotion, mutiny, accident, earthquake, fires, floods, orders and / or restrictions and other cause beyond the reasonable control of the vendor. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper documents / proofs to the entire satisfaction of WBSEDCL.
- **GCC.3.2.** WBSEDCL will not take any additional liability towards enhanced taxes, duties and price variation due to force majeure condition.
- **Cancellation/Termination of Order:** Proper maintenance of the Routers to keep the same in working condition to be essence of contract and if, the bidder fail to do so within the contractual period, WBSEDCL shall be entitled to get it done with the best and nearest available substitute on the account and at your risk or to cancel the contract and you

shall be liable to compensate for any loss or damage which WBSEDCL may sustain by reason of such failure on your part.

- **GCC.4.1.** Non acceptance of LOA as per "Acceptance" clause.
- **GCC.4.2.** Non submission of Performance BG within time.
- **GCC.4.3.** If the performance of the work which entrusted to you is not found satisfactory.
- **GCC.4.4.** If the vendor is found to have "Conflict of Interest".
- **GCC.4.5.** In each above cases 15 days termination notice shall be issued prior to termination of LOA.
- **GCC.4.6.** If vendor fails to execute the job within 1 month from placement of LOA then WBSEDCL may terminate the order and place it to next successful bidder.
- GCC.4.7. If the performance of the work which is entrusted to successful bidder (L1) is not found satisfactory and order is terminated, then the L2 bidder may be awarded the LOA, if they are agreed to the rate of L1 bidder with same terms and conditions of L1 bidder. If the L2 bidder is not willing to perform the job or fails to execute the same then the next successful bidder will be approached to carry out the job with the same terms and conditions.

## GCC.5. Performance Guarantee:

An amount of 110% of total sum of 100% of yearly rental charges (Link+Anti DDOS) excluding tax shall be the Bank Guarantee against advance payment with validity up to 30.09.2026 from LOA and claim period of three (3) months beyond validity period. The Bank Guarantee is to be submitted within 30 days from issuance date of LOA on non-judicial stamp paper of Rs.100/- by any Schedule Bank of RBI, as per format enclosed (ANNEXURE-IV). The BG shall be submitted to the CE, IT&C Cell, 3rd Floor, 'D' Block, Vidyut Bhawan, WBSEDCL.

An additional performance guarantee equivalent to 10% of the contract amount has to be submitted by successful bidder if the bid is in the range of -20% to -80% of the estimated rate. Validity of PBG will be 2 years from the date of LOA and claim period will be further 3 months. The additional performance guarantee should be in the form of Bank Guarantee on non-judicial stamp paper of Rs.100/- by any Schedule Bank of RBI, as per format enclosed (ANNEXURE-VI). The additional PBG shall be submitted to the CE, IT&C Cell, 3rd Floor, 'D' Block, Vidyut Bhawan, WBSEDCL.

## GCC.6. Arbitration & Legal Jurisdiction:

- **GCC.6.1.** During execution of this contract, if any dispute arises thereby, shall be settled amicably between WBSEDCL and yourself to the extent possible.
- All disputes or differences in respect of which the decision if any has not become final shall be settled through proper judicial procedure under the jurisdiction of Hon'ble High Court, Calcutta only. No arbitration procedure shall be allowed.
- **GCC.6.3.** The necessary legal affairs and / or court case shall be exclusively within the jurisdiction of Calcutta High Court only.

# GCC.7. Liquidated damage:

The timely completion of entire project including handing over the site to WBSEDCL as per "Execution Period" is the basic consideration and essence of the contract and WBSEDCL reserves the right to repudiate the contract if you fail to complete the work within stipulated period for completion. However, the ordering authority may at his discretion waive this condition with imposition of liquidated damage indicated herein below.

**GCC.1.1. Delay in establishment of ILL connectivity:** If you fail to complete the work

(DDOS + ILL connectivity) within the completion time as stated in the Clause of "Execution Period", a L.D. at the rate of ½% of total order value per day of delay or part thereof subject to a maximum of 10% of total order value shall be imposed on you. As it is a turn-key project & mere provision of link cannot be construed as completion of work, hence for the purpose of this clause, work will be treated as finished only when successful commissioning by site in charge, trial run and handover-takeover of the said ILL connectivity is complete. Otherwise the total order value of work for that connectivity will be treated as unfinished and L.D. will be deducted from bills.

- **GCC.1.2.** Liquidated Damage, if applicable during warranty period, will be recovered from any outstanding bills / bank guarantee lying / to be lying with WBSEDCL.
- GCC.8. Risk Purchase / Performance: Adherence to time schedules mentioned in the foregoing clauses shall be deemed as the essence of contract and if the vendor fail to deliver within the periods prescribed for such work in the rate contract order, WBSEDCL shall be entitled to execute the job through the best and nearest substitute available elsewhere on the account and at the risk of the contracting agency or to cancel the contract and the contracting agency shall be liable to compensate for any loss or damage which WBSEDCL may sustain by reason of such failure on the part of the Contracting Agency.

# GCC.9. Submission of bills for payment:

**GCC.9.1.** All the bills in triplicate along with forwarding letter relevant papers &documents are to be submitted to the IT & C Cell and will be addressed to the Chief Engineer IT&C cell.

# GCC.10. Terms of Payment:

- **GCC.10.1. For Lease line and Anti DDOS service on rental basis:** As per applicability of dates for ILL1 and ILL2 links as mentioned earlier in General terms and Conditions.
- **GCC.10.2. On Link commencement**: Rental charges for the period from date of commissioning of ILL connectivity to 31/03/2025 will be paid in advance against proforma invoice on submission of 110% of Performance Bank Guarantee which will be total yearly rental of Link and Anti DDOS service charges.
- GCC.10.3. \_After 1st Year i.e., after 31/03/2025 :
  - **GCC.10.3.1.** Final bill for the 1st year -Final bill for the period from date of commissioning of ILL connectivity and DDOS to 31/03/2025 along with that of system generated downtime for the period from date of commissioning of ILL connectivity and DDOS to 31/03/2025 against SLA.
  - GCC.10.3.2. Advance for the period the 2nd year i.e., from 01/04/2025 to 31/03/2026 100% Yearly rental charges for the period from 01/04/2025 to 31/03/2026 will be paid in advance against proforma invoice for link and Anti DDOS.
- GCC.10.4. After 2nd Year i.e., 31/03/2026:
  - **GCC.10.4.1.** Final bill for the 2nd year -

Final bill for the period from 01/04/2025 to 31/03/2026 along with that of system generated downtime for the period from 01/04/2025 to 31/03/2026 against SLA for both Link and Anti DDOS.

- **GCC.10.5.** No partial bill would be entertained. If a site is commissioned or upgraded in a particular bill period then the bill for that site to be claimed in bill of that period only.
- **GCC.10.6.** System generated Monthly downtime report is to be submitted by you for the bill period to WBSEDCL for calculation.
- All the bills in triplicate with relevant documents to be submitted in both hard and its soft copy to the Controlling Officer at IT & C Cell for payment. Soft copy to be mailed at network.itcell@wbsedcl.in.The soft copy should be same as hard copy.

- **GCC.10.8.** The commissioning certificate (to be provided by Site in charge)) of ILL connectivity signed by controlling officer should be provided along with 1st bill.
- **GCC.10.9.** Payments will be made through NEFT/RTGS mode in designated Bank details provided by you.
- **GCC.10.10.** If you fail to submit normal rent bills of ILL link prior to two months of expiry of BG in consideration to the validity and claim period of the BG, the said BG shall be invoked by WBSEDCL without further reference.
- **GCC.10.11.** Billing for bandwidth and DDOS would be done on pro-rata basis of rate quoted for any other bandwidth. Eg. If Company X ,gets successful as L1 and takes 7 days time for link upgradation form 100 to 200 Mbps then for 7 days 100 Mbps billing would be done on pro-rata basis of rate quoted for 200 Mbps.
- **GCC.11.** Access Security Policy To be submitted by bidder as per Annexure X.

#### **GCC.12.** Confidentiality and Contract Agreement:

The bidder shall agree that they shall keep all information and facts which may come to their knowledge during the term of this contract as confidential information including configuration, data, procedures and any information to which WBSEDCL becomes a party pursuant to this contract or any activities of the WBSEDCL. It is further agreed that this does not preclude from disclosing this information to any statutory authorities, government, court or investigation agencies etc. if due notice is served for disclosing such information. However before disclosing such information you shall consult WBSEDCL. In this regard a Non-Disclosure Certificate (Annexure-VIII) and Contract Agreement (Annexure-IX) to be submitted along with LOA acceptance and undertakings. You shall have to be entered into a Contract Agreement 15 (fifteen) days from the issue of the Letter of Award (LOA) with West Bengal State Electricity Distribution Company Limited (WBSEDCL) for the proper fulfilment of the contract as per Proforma (ANNEXURE-IX).
