- 1. Rate:- The rate should be firm, fixed and final inclusive of all Taxes and charges.
- 2. Payment:- 100% payment will be made in due course by the Drawing & Disbursing Officer/ A.M(F&A), P.P.S.P Site, Bagmundi, W.B.S.E.D.C.L against the bill in triplicate and signed challan in original along with a copy of the order which should be submitted to this end, after delivery of the ordered articles.
