Payment: 90% Payment will be made after successful completion of work, drawal of Service Acceptance from this end and on submission of original bill/ Tax Invoice in triplicate with advanced pre-receipt (Duly signed on Revenue Stamp), Guarantee/warranty Certificate & challan which are to be submitted at the time of delivery of materials. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency.

Rest 10% of the ordered amount will be kept as security deposit and it will be released after successful completion of guarantee period.
