n) The bidder's Minimum Average Annual Turnover (MAAT) for last 03 (three) Financial Years (2017-18, 2018-19 and 2019-20) shall not be less than 30% of the estimated cost.

o) The working capital of the bidder in the preceding year of bid submission shall not be less than 30% of the estimated cost.

p) In case documents certifying credit facility from a scheduled bank is submitted, the requirement given in clause no (o) shall be judged by adding available credit facility and working capital taken together.
