- I. **Delivery of material:** Within 45 (Forty Five) days from the date of issuance of the order.
- II. **Place of delivery:** The materials will be delivered at PPSP Site Store, WBSEDCL, Bagmundi, Purulia
- III. E-Way Bill: The generation of E-way Bills for all goods supplied under this tender, shall lie with the Bidder/Contractor. This includes situations where the goods are supplied to the Tender Inviting Authority's premises or to any other designated location."if Required.
- IV. **Transit insurance**: The bidder shall be exclusively responsible for procuring and maintaining comprehensive transit insurance for all goods, materials.
- V. **Price**: Price should be firm inclusive of all incidental charges. GST value and percentage to be written separately in quotation. However, GST will be applicable as per law of land at the time of placement of order. STDS will be deducted as per norms.
- VI. **Delivery Charge**: Delivery charge will be borne by the Agency.
- VII. **Payment**: Ninety percent (90%) of the contract value will be paid preferably within 45 (Forty-Five) Days after successful delivery and acceptance of materials. Ten percent (10%) will be retained as Security Deposit (SD) and will be refunded after expiry of the guarantee/warranty period on receiving application from the vendor. Materials will be received at site through raising Store Receipt Voucher (SRV). Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency at time of delivery. In case of part delivery of materials payment will be made accordingly. Payment will be made through R.T.G.S/N.E.F. T (R.T.G.S/N.E.F. T charge to be borne by the Agency).
- VIII. **BG/BD**: 10 % of the quoted value as additional performance security will have to deposited, if the bidder quotes in the range of -20% to -80%.

- XIII. Guarantee/Warranty:Original manufacturer guarantee/warranty or 12 months whichever is greater is to be provided for equipments and materials. In case the supply materials are beyond our specification or found defective/damage /broken within declared Guarantee/Warranty period from the date of delivery of materials, the same should be replaced by you at your own cost and responsibility.
- XIV. PAN/GST NO: Bank Details with cancelled cheque is to be provided. GSTIN acknowledgement of registration is to be provided.
- XV. Validity: The offer must remain valid for 120 days from the date of opening of the Tender.
- XVI. **Rejection**: WBSEDCL reserve the right to reject any or all offers at its own direction without assigning any reason whatsoever and do not bind itself to accept the lowest bidder.
- XVII. Risk purchase clause & Force majeure: will be applicable as per norms of WBSEDCL.
- XVIII. Evaluation of Bid: Offer will be evaluated on cumulatively basis to the lowest offer.
- XIX. **Additional Liabilities**: The WBSEDCL shall not take any additional liability towards enhanced taxes, duties beyond the scheduled delivery period as incorporated in the purchase order, if the delay is due to any failure on the part of the Supplier.
