### **NOTICE INVITING e-TENDER**

Tenders are invited by the Addl. CE and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL, Admin. Bldg., Phansidewa, Darjeeling-734434 through electronic tendering (e-tendering) from the reputed vendor for taking up the supply work on **item rate basis**.

 Name of work: Supply & delivery of LED indication lamp and push buttons for TCFHP under WBSEDCL as per schedule of supply.

- 3. Earnest Money Deposit: ₹ 9,416/- (Rupees Nine Thousand four hundred sixteen Only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>) online. As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.
- 4. Eligibility Criteria: Any reputed vendor having valid PAN card, Trade License, GST Registration certificate and Up to date P. Tax clearance certificate will be considered eligible in participation.

## Bid Guarantee/Earnest Money:

- a. A bidder desirous of taking part in a tender invited by offices of WBSEDCL shall login to the e-Procurement portal of Government of west Bengal <a href="https://www.wbtenders.gov.in">https://www.wbtenders.gov.in</a> using his login Id and password.
- b. The bidder shall select the tender to bid and initiate payment of EMD. Following payment options are available for paying EMD amount through online mode:
  - NET-BANKING THROUGH PAYMENT GATEWAY.



- Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the prefilled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.
- iii) Submission of EMD through BG: Submission of EMD in the form of BG is not allowed.

#### c. General Instructions for Online Payment:

- i) The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.
- ii) Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.) As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicacy.
- iii) In case actual EMD amount as per NIT is more than the one shown in e-Tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
- iv) The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated

### d. Refund/ Settlement of EMD Amount:

- i) For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- ii) For successful bid(s), EMD will be refunded from WBSEDCL authority after completion of tendering process and following due procedures.
- iii) The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
- iv) For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, 033\_40267512/13 since payment gateway facility used by E-tender portal is maintained by ICICI
- e. The bid guarantee is required to protect WBSEDCL against the risk of bidder's conduct, which would warrant the bid guarantee forfeiture.
- f. The bid guarantee shall be forfeited:
  - i) If during the period of validity specified by the bidder, the bidder withdraws/modifies it's bid as a whole or in part.



- ii) If the bidder deviates from any clarification/confirmation given by him subsequent to submission of his bid.
- iii) In case of successful bidder, if the bidder fails to accept LOI/LOA/Order unconditionally and sign contract
- g. No interest shall be payable by WBSEDCL on the above bid guarantee/ Earnest money.

Exemption from deposition of Bid Guarantee/Earnest Money Deposit (EMD) shall not be allowed under any circumstances

#### 6. Process to be Confidential:

- i) After the opening of bids, information relating to the examination, clarification, evaluation and comparison of bids and recommendations concerning the award of contract shall not be disclosed to bidders or other persons not officially concerned with such process.
- ii) Any effort by a bidder to influence WBSEDCL or other connected in the process of examination, clarification, evaluation and comparison of bids, and in decisions concerning the award of contract, may result in the rejection of his/their bid.
- iii) Formation of any cartel, may lead to the cancellation of tender with penal measures as necessary and WBSEDCL reserves to right to take such unilateral decisions without further notice to anyone
- Successful bidder(s) shall have to mandatorily create vendor ID through WBSEDCL Vendor Corner, if not created earlier.
- 8. In the event of e-filling intending contractors/bidders desirous of participating in the e-Tender should download the tender documents from the website <a href="http://www.wbtenders.gov.in">http://www.wbtenders.gov.in</a> directly with the help of Digital signature Certificate.
- 9. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Bidder through the website <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a> and should be submitted online on or before as per the 'Date &Time Schedule'.
- 10. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
- 11. No mobilization advance and secured advance will be allowed.
- 12. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.



- 13. The offer against tender should remain valid for a minimum period of 120 days from the next day of opening of the tender. However, WBSEDCL may, on the merit of case, request for extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
- 14. The instant e-NIT will be processed in line with prevailing Revised Purchase Policy of WBSEDCL as available in <a href="http://www.wbsedcl.in">http://www.wbsedcl.in</a> website.

- 18. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
- Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
- 20. Conditional / Incomplete tender will not be accepted under any circumstances.
- 21. The intending Bidders are required to quote the rate online at www.wbtenders.gov.in
- 22. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.



- Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
- 24. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
- 25. The participating bidders may please note that the successful bidder shall have to submit an Indemnity Bond in the prescribed format before commencement of the work.
- 26. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
- 27. Revised Purchase Policy will be followed wherever applicable in respect of the contract work. Revised Purchase Policy is available ay company's website.
- 28. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
