- 8. No mobilization advance and secured advance will be allowed.
- 9. Constructional labour Welfare Cess @ 1% (One percent) of cost of construction will be deducted from every bill of the selected agency, which is not included in the rate of items provided in the P.W.D Schedule Of rates and added later on.
- 10. Bid shall remain valid for a period not less than 180 (One Hundred And Eighty) days from the date of opening of financial bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited without assigning any reason thereof.
