- 1. Earnest Money: Rs. 11,625.00/- (Rupees Eleven Thousand Six Hundred and Twenty-Five Only)
- 2. Eligibility Criteria: The Bidder must possess minimum eligibility criteria as mentioned below:
 - a. The bidder must be the manufacturer or authorized channel partner or authorized dealer of 12 Volt, 120 Ampere-hour, Sealed Maintenance Free (SMF) batteries and shall have credential for successful supply of the same to WBSEDCL / WBSETCL / WBPDCL / NHPC/ Power Grid / NTPC or any other Power Utility / Govt. undertaking Company / PSU / Semi Govt. / reputed private sector company of India during last Seven (07) years.
 - b. The bidder must have Valid GST Registration Certificate
 - c. The bidder must have PAN Card
 - **d.** License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).

The Bidder shall produce original copy of the documents i.r.o. eligibility criteria, if so required by WBSEDCL. Any discrepancies found by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

5. Scope of Work:

Supply and Delivery of below mentioned SMF Batteries to Rammam Hydel Project Site and taking return of the old exhausted batteries under buyback scheme from Rammam Hydel Project Site, Stage-II, WBSEDCL, Lodhomahat, Darjeeling-734201. The batteries should be supplied as per Technical Specification mentioned in **Chapter 4** later in this document.

- **6. Validity:** The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of Earnest Money Deposit (EMD).
- 7. Conditional / Incomplete tender will not be accepted under any circumstances.
- 8. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice and the earnest money deposited will be forfeited.
- 9. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is found incorrect / manufactured / fabricated or false at any stage, his Tender will be rejected with forfeiture of earnest money and legal action may be taken against him.
- 10. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.
- 11. WBSEDCL reserves the right to:
 - > Amend the scope of work to be tendered.
 - Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
 - > Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

12. WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required.

13. No price preference will be allowed to any agency/supplier/contractor based on the size of the company or its geographic location. Co-operative Society / MSME will not be considered with separate status.
