Terms & Conditions:

1. **Job Description:** The Refilling & Delivery of 28 nos. (ABC & CO2 type) existing fire extinguishers at Hydel Head Quarters, WBSEDCL, Siliguri. Mock drill for use of all types of Fire Extinguisher should be categorically done at the respective sites. After lifting of fire extinguisher for refilling, requisite no of spare valid fire extinguisher from your end should be installed at respective sites for meeting any exigencies.
2. **Price:** The price is to be quoted as per schedule and should be net and firm inclusive of all incidental charges. The Provision of taxes & duties, if any, shall be governed by prevailing Govt. rules.
3. **Completion period:** The work is to be completed within 30 (Thirty) days from the date of issuance of order.
4. **Liquidated Damages:** Supply and delivery (physical delivery of Equipment / Materials at the place of delivery in accordance with the Delivery Instruction) /erection/construction of the Equipment /Materials as well as execution of the entire work should be as per the delivery schedule/schedule of completion of work. If the Equipment / Materials/ erection/construction are not delivered/work is not completed within stipulated period as per schedule, WBSEDCL reserves the right to repudiate the Order (LOA). But the Purchaser may, at his discretion, extend the delivery schedule/execution schedule subject to imposition of liquidated damages at half percent (0.5%) of the Contract price for per week of delay or part thereof for first 10 (ten) weeks and @ 1% (one percent) of value per week beyond 10 (ten) weeks subject to a maximum of 10% of the contract price /Ordered value and accept the refilling work beyond the stipulated period. Liquidated damages, if any, shall be recovered from your bill.
5. **Tools & tackles:** The agency should arrange all tools & tackles required to execute the job.
6. **Payment:** 90% payment along with taxes and duties will be made after successful refilling & installation of existing Fire Extinguishers and against submission of your GST prescribed invoice in triplicate. The payment will be made through fund transfer. Necessary Bank charges will be borne by you. You need to provide your Bank A/C No, IFS Code, Name of the Bank & Branch and Cancelled Cheque.
7. **Security Money:** Security money shall be deducted from the bill at 10% (ten percent) of works as actually done. All security money shall be refunded, either in full or part as the case may be, after the expiry of warrantee period. This period of maintenance shall be counted from the date of completion of job.
8. **Statutory Deduction:** WBSEDCL shall deduct all the statutory taxes i.e. income tax, work contact tax, as applicable at source from the Invoice in accordance with the provision of statutory obligation as applicable.
9. **Validity period:** The entire rate should remain valid for a period of 90 days from the date of opening of tender.
10. **Guarantee Period:** The entire work shall have to be guaranteed for a period of one year from the date of completion of work. In case, there is any problem in operation of mentioned Fire Extinguisher, the same shall have to be corrected as per the requirement.

11. **Extension of time:** An extension of time without imposition of penalty, may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted within the schedule date of completion by the contractor who has to establish that the extension of time required by him is not due to his fault.

(a) Causes for Extension of Time for Completion:

The tenderer may claim an extension of the Time for Completion if the work is delayed due to any of the following causes:

- (i) Extra or additional work ordered in writing by WBSEDCL.
- (ii) Suspension of work ordered in writing.
- (iii) Delay by any other Contractor engaged by WBSEDCL, affecting this Contract.
- (iv) The WBSEDCL's Risks, if any when they constitute the sole reason for the delay in completion of Works.
- (v) Delay in hand over of site by WBSEDCL.
- (vi) Force Majeure.

The tenderer shall give notice to WBSEDCL of his intention to make a claim for an extension of time within 7 days of the occurrence of any of the above cause(s). The notice shall be followed as soon as possible by the claim with full supporting details.

13. **Force Majeure:**

- (i) Definition of Force Majeure

Force Majeure means any circumstances beyond the control of the parties, including but not limited to:

- (a) War and other hostilities, (whether war be declared or not), invasion, act of foreign enemies, requisition or embargo.
- (b) Rebellion, revolution, insurrection, military or usurped power and civil war.
- (c) ionizing radiation or contamination by radio activity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosives, or other hazardous properties of any explosive nuclear assembly or nuclear components thereof.
- (d) Riot, commotion or disorder.
- (e) Earthquake, Flood, Cyclone and such other natural disaster.

14. The tenderers may visit the site for getting an idea of detailed job involvement before quoting the rate.
