 2. Current challan for depositing Professional Tax (PT)
 3. Copy of IT return for last three financial years, PAN Card, as applicable.
 4. Trade License
 5. Performance Certificate as Prime Contractor for execution of similar nature of works for last Seven years and details of works in hand.
 6. Information regarding any past and current litigation with WBSEDCL/WBSETCL/Govt./PSU in which the bidder is involved, the party is concerned and disputed amount, wherever applicable.

6. Bids shall remain valid for a period not less than 180 (One hundred Eighty) days after date of bid opening of tender. 
