### **NOTICE INVITING e-TENDER**

**Tender Notice No.: TCFHP/e-Tender/22-23/23 dt. 16.01.2023**

The Addl. CE and Project Manager, Teesta Canal Fall Hydel Project, WBSEDCL invites e-tender (Submission of Bid through online) for the work detailed below **on percentage basis**:

**1. Name of the work:**

Erection & commissioning of 01 no. 20 MVA, 132/33KV Power Transformer with all accessories at PS-II, TCFHP including **a)** Road transportation including transit insurance of 01 no. 20 MVA, 132/33 KV Power Transformer with all accessories from PS-I TCFHP to PS-II, TCFHP. **b)** Temporary charging arrangement of 12.5 MVA PTR at PS-II till completion of Erection & commissioning work of 01 no. 20 MVA, 132/33KV Power Transformer with all accessories at PS-II, TCFHP. **c)** Dragging & stacking of 12.5MVA 132/33KV Power Transformer & 01 No. 7.5 MVA 132/33KV Power Transformer with all accessories at suitable place inside the Power Station-II of TCFHP, WBSEDCL, Haptiagachh, Distt: Uttar Dinajpur (W.B).

(Oil Filter Machine of capacity 03 KL and Empty Drums will be provided by WBSEDCL for above works.)

Note: Details of work has been mentioned in section "D" containing Scope of work.

- 2. Estimated Cost:** ₹ 10,42,596.50/- (Rupees ten lakh forty two thousand five hundred ninety six and paise fifty only). GST will be paid extra as per statute. Charges of transit insurance will be paid as per actual against the submission of insurance papers.

(Note: Quantity may be vary as per site requirement and payment will be made for actual executed work).

- 3. Completion Time:** The entire work should be completed within 45 (forty five) days from the date of handing over the site.

- 4. Earnest Money Deposit:** ₹ 26,065.00/- (Rupees twenty six thousand sixty five only). All participating bidders are exempted from payment of Tender Fee. Earnest Money Deposit (EMD) in e-tendering process will be collected and refunded in online mode via dedicated bank account maintained at corporate level instead of depositing DD/Pay Order to the tender inviting authority. The amount of Earnest Money Deposit (EMD) is to be submitted through online mode through the e-Tendering portal (<https://wbtenders.gov.in>) online. As per the procedure defined for online collection in e-tender process, EMD amount deposited by bidders is initially held in a pool account of Government of West Bengal maintained by ICICI. Only the amount corresponding to successful bid will be transferred to WBSEDCL Bank Account after completion of tendering process on awarding Award of Contract (AOC). For technically rejected bids, EMD amount will be automatically returned to bidders after the bid is technically rejected in e-tender portal. However for successful bids, the EMD will be refunded by WBSEDCL as per norms after completion of tendering process.

### 5. Eligibility Criteria:

- i) Successfully executed Erection & commissioning work of atleast 01 no. 20 MVA, 132/33K Transformer or above in a single contract having value not less than 05 (five) lakh in a single contract during last 5 (five) years.
- ii) Valid Electrical Contractors' License with suitable Supervisory Competency Certificate on appropriate parts
- iii) GST Registration certificate.
- iv) Up to date P. Tax clearance certificate.
- v) PAN Card.
- vi) Valid Trade License.

### 6. Bid Guarantee/Earnest Money:

- a. A bidder desirous of taking part in a tender invited by offices of WBSEDCL shall login to the e-Procurement portal of Government of west Bengal <https://www.wbtenders.gov.in> using his login Id and password.
- b. The bidder shall select the tender to bid and initiate payment of EMD. Following payment options are available for paying EMD amount through online mode:

#### i) NET-BANKING THROUGH PAYMENT GATEWAY.

- ii) **RTGS/NEFT Payment:** On selection of RTGS/ NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction. The bidder will print the challan and use the prefilled information to make RTGS/NEFT payment using his bank account. Once the payment is made, the bidder will come back to the e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NEFT process to be completed.

- iii) **Submission of EMD through BG:** Submission of EMD in the form of BG is not allowed.

### c. General Instructions for Online Payment:

- i) The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.

- ii) Status of NEFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.) As such bidders opting to pay through NEFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
- iii) In case actual EMD amount as per NIT is more than the one shown in e-Tender Portal, bidders will have to opt for NEFT/RTGS mode (challan mode). In that case the total actual EMD amount is to be paid only through NEFT/RTGS mode (challan mode).
- iv) The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated

### d. Refund/ Settlement of EMD Amount:

- i) For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
  - ii) For successful bid(s), EMD will be refunded from WBSEDCL authority after completion of tendering process and following due procedures.
  - iii) The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.
  - iv) For any queries related to payments and refunds, bidders will have to communicate with ICICI Customer Support, viz, **033\_40267512/13** since payment gateway facility used by E-tender portal is maintained by ICICI
- e. The bid guarantee is required to protect WBSEDCL against the risk of bidder's conduct, which would warrant the bid guarantee forfeiture.
- f. The bid guarantee shall be forfeited:
- i) If during the period of validity specified by the bidder, the bidder withdraws/modifies it's bid as a whole or in part.
  - ii) If the bidder deviates from any clarification/confirmation given by him subsequent to submission of his bid.
  - iii) In case of successful bidder, if the bidder fails to accept LOI/LOA/Order unconditionally and sign contract

**Exemption from deposition of Bid Guarantee/Earnest Money Deposit (EMD) shall not be allowed under any circumstances**

### 7. Process to be Confidential:

- i) After the opening of bids, information relating to the examination, clarification, evaluation and comparison of bids and recommendations concerning the award of contract shall not be disclosed to bidders or other persons not officially concerned with such process.
- ii) Any effort by a bidder to influence WBSEDCL or other connected in the process of examination, clarification, evaluation and comparison of bids, and in decisions concerning the award of contract, may result in the rejection of his/their bid.
- iii) Formation of any cartel, may lead to the cancellation of tender with penal measures as necessary and WBSEDCL reserves to right to take such unilateral decisions without further notice to anyone

8. Successful bidder(s) shall have to mandatorily create vendor ID through WBSEDCL Vendor Corner, if not created earlier.
9. In the event of e-filling intending contractors/bidders desirous of participating in the e-Tender should download the tender documents from the website <http://www.wbtenders.gov.in> directly with the help of Digital signature Certificate.
10. Both **Technical Bid and Financial Bid** are to be submitted concurrently duly digitally signed by the Bidder through the website <https://wbtenders.gov.in> and should be submitted online on or before as per the clause 'Date & Time Schedule'.
11. The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
12. No mobilization advance and secured advance will be allowed.
13. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. If found to have applied severally in a single job, all his offers will be rejected for that job.
14. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the last date of submission of Financial Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money deposit (EMD).

The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
20. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
21. Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.
22. Conditional / Incomplete tender will not be accepted under any circumstances.
23. The intending Bidders are required to quote the rate online at [www.wbtenders.gov.in](http://www.wbtenders.gov.in)
24. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
25. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
26. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by the Bidder in support of eligibility criteria. If any document submitted by a Bidder is incorrect / manufactured / fabricated or false at any stage, his Tender will be outrightly rejected and legal action will be taken against him.



27. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
28. Revised Purchase Policy will be followed wherever applicable in respect of the contract work. Revised Purchase Policy is available at company's website.
29. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
