- 2. Price: The total price is to be quoted as per schedule of work (Annexure-A attached) and should be net and firm inclusive of all incidental charges. The Provision of Taxes and Duties, if any, shall be governed by Govt.
- 3. Completion period: Time is the essence of contract. The work is to be completed in all respect within 15 (Fifteen) days from the date of issuance of work order from the office of the DL(E). MMHD. Kurseong.
- 4. Payment: Payment will be made through NEFT/RTGS to you on submission of Tax Invoice in triplicate to the Controlling Officer along with necessary documents. Necessary bank charges will be borne by you You need to provide your bank accounts details such as IFSC code. A/C number along with bill to be submitted in GST prescribed format.
- 5. Extension of Time: An extension of time without imposition of penalty, may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted within the schedule date of completion by the contractor who has to establish that the extension of time required by him is not due to his fault.

(a) Causes for Extension of Time for Completion

(v) Delay in hand over of site by WBSEDCL.

(vi) Force Majeures

The Contractor shall give notice to WBSEDCL of his intention to make a claim for an extension of time within 7 days of the occurrence of any of the above cause(s). The notice shall be followed as soon as possible by the claim with full supporting details.

6. Force Majeure:

Definition of Force Majeure Force Majeure means any circumstances beyond the control of the parties, including but not limited



Effect of Force Majeure (ii) Neither party shall be considered to be in default of in breach of his obligations under the Contract to the extent that performance of such obligations is prevented by any circumstances of Force Majeure which arise after the date of the Letter of Award or the date when the Contract becomes effective. whichever is the earlier.

Notice of Occurrence (iii) If either party considers that any circumstances of Force Majeure have occurred which may affect performance of his obligations, he shall promptly notify the other party

Performance to Continue it so (1) (iv) Upon the occurrence of any situation of Force Majoure, the Contractor shall endeavor to continue to perform his obligations under the Contract so far as reasonably practicable. The Contractor shall
