## **GENERAL TERMS AND CONDITIONS:**

- 1. ELIGIBILITY CRITERIA: The Bidder must possess minimum eligibility criteria as mentioned below:
  - a. Valid GST Registration Certificate
  - b. PAN Card
  - c. License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).
- d. The Bidder shall have experience of successful delivery of similar kind of item under WBSEDCL / WBSETCL / WBPDCL / NHPC/ Power Grid / NTPC or any other Power Utility / Govt. undertaking Company/ Private Company anywhere in India during last five (05) years.
- 2. **SCOPE OF WORK:** Repair and maintenance of LAVT and NG cubicle of Unit-3 for resolution of problem of partial discharge at RHP St-II, Dovan, P.O.-Lodhomahat, Dist.-Darjeeling.
- **3. COMPLETION PERIOD**: The said job is to be completed within 30 (thirty) days from the date of handing over of the site.

- 8. RISK PURCHASE: The time of delivery or stipulated in this purchase order shall be deemed to be the essence of the order and if you fail to deliver any consignment within the period prescribed for such delivery as mentioned above, WBSEDCL shall be entitled to purchase such consignment or if not available, the best and nearest available substitute elsewhere on your account and at your risk or to cancel the order and you shall be liable to compensate for any loss or damage which WBSEDCL may sustain by reason of such failure on your part.
- 9. STATUTARY TAX & SETTLEMENT OF DISPUTES: Income tax and TDS together with GST will be deducted or paid as per norms from the Invoice. All disputes shall be settled amicably and where settlement cannot be reached then disputes shall be subjected to settlement under the jurisdiction of Darjeeling Court/ Calcutta High Court.
- 10. CONTROLLING OFFICER: The Superintending Engineer (E), Rammam Hydel Project, Stage -II, WBSEDCL will be the Controlling Officer.
- **11. SUPERVISING OFFICER**: The Divisional Engineer (E), In-charge of PH, Rammam Hydel Project, Stage -II, WBSEDCL will be the Supervising Officer.
- 12. PAYING OFFICER: The Manager (F&A), Rammam HP, Stage II.
