- 1) West Bengal State Electricity Distribution Company Ltd. (WBSEDCL) invites sealed quotation from reputed vendors for **Services for rectification and straightening work of mis-aligned shafts including To and Fro transportation of shafts from PPSP Site and delivery of the rectified shafts at PPSP Site** as per the specification mentioned in Annexure-I for Purulia Pumped Storage Project Site. The sealed cover shall be super scribed with "NIT No" Name & Date of the Tender and "Date & Time of opening of the Tender". The sealed cover shall also bear the name and address of the tenderers.

 - (a) **Services for rectification and straightening work of mis-aligned shafts and after the rectification work the shaft run out should not be more than 0.1 mm.**

1. **Completion Time:** Within 45 days after receiving the date of confirmed order.
2. **Place of Service:** Workshop of the successful bidder. However, successful bidder shall be responsible to collect and subsequently deliver the items to Purulia Pumped Storage Project Site, WBSEDCL, Bagmundi, Purulia.
3. **Price:** Price should be firm inclusive of all incidental charges. GST should be mentioned separately as applicable.
4. **Payment:** 100% of total order value along with GST for service will be made within thirty (30) days from the date of successful completion of service and submission of Invoice in triplicate, Test/ Shaft Run out Certificate and Examination Report. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency.
5. **Paying Authority:** The Assistant Manager (F&A), PPSP Site, WBSEDCL, Bagmundi, Purulia.
6. **Controlling Officer:** The ACE & PSIC, Purulia Pumped Storage Project Site, WBSEDCL, Bagmundi, Purulia (Mob: 9735801266).
7. **Supervising Officer:** The DE(M) or his authorized representatives, PPSP Site, WBSEDCL, Bagmundi, Purulia.
8. **Inspection:** The service will be subject to thorough inspection on the Contractor's premise at his own cost and risk. On completion of job, contractor will deliver prior notice of inspection, which will be attended by the Controlling officer or his authorized representative at the contractor, premise. Dispatch clearance of the rectified materials will only be given on successful completion of inspection.
9. **Legal Jurisdiction:** If any dispute or difference arises with respect to quality / quantity of the equipment / material pertaining to this order or any other terms and conditions of the order including its execution, such dispute / difference shall be subject to settlement under the jurisdiction of court in Kolkata only.
10. **Additional Liabilities:** The WBSEDCL shall not take any additional liability towards enhanced taxes, duties beyond the scheduled completion period as incorporated in the service order, if the delay is due to any failure on the part of you.
11. **Liquidated Damages:** WBSEDCL reserves the right to repudiate the contract, if the service work not completed within stipulated time period as per work completion time clause. Liquidated damage @ 1/2% of the value of the service order for each week of


delay or part thereof upto 10(ten) weeks and @ 1% of the value per week beyond 10 weeks subject to maximum of 10%. Liquidated damage, if any involved, shall be recovered from the outstanding bills/ Bank Guarantee.

12. **Risk Purchase Clause:** On cancelation of the contact in full or in part the Employer shall determine what amount, if any, is recoverable from the contractor for completion of the work or part of the works or in case the works or part of the works is not to be completed, the loss or damaged suffered by WBSEDCL. In determining the amount, credit shall be given to the contractor for the value of the work executed by him up to the time of cancelation, the value of contactors materials taken over and incorporated in the work and use of plant and machinery belonging to the contractor. Any excess expenditure incurred or to be incurred by WBSEDCL in completing the works or part of the works or the excess loss or damages suffered or may be suffered by WBSEDCL as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to WBSEDCL in law be recovered from any moneys due to the contractor on any account, and if such moneys are not sufficient, the contractor shall be called upon in writing and shall be liable to pay the same within 30 days.
13. **Safety Measures & All Risk & Responsibility:** All the safety rules and codes as applicable to the work shall be followed by you without any exception. All risk & responsibility of your Team for any accident and/or unforeseen hazard shall lie entirely on you. PPSP, WBSEDCL shall in no way be held responsible under any circumstances in this regard. Necessary risk coverage is required to be arranged by you as per law of the land.
14. **Force Majeure:** You shall be under no liability if you are prevented from carrying out any of your obligations by reason of war, invasion, act of foreign country, hostilities (whether war declared or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods Govt. order and/or restrictions (except power supply restriction) delay or inability to obtain materials due to import or other statutory restriction and other cause beyond the reasonable control of the supplier / service provider. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper documents/proofs to the entire satisfaction of the purchaser/ service provider.
15. **Transportation:** Receiving the defective shafts from PPSP Site, delivery of the rectified shafts at PPSP Site, to and fro transportation of items including arrangement of manpower for loading and unloading will be in the scope of service provider.
16. **Vendor Details:** PAN/GSTIN no. & bank NEFT/RTGS details are to be provided for vendor approval along with a cancelled cheque.
17. **Validity:** The offer must remain valid for 90 days from the date of opening of the tender.
18. **Rejection:** WBSEDCL reserves the right to reject any or all offer at its own discretion without assigning any reasons whatsoever and do not bind itself to accept the lowest tender.
