#### 1. Technical specification:

iv. The rejected materials shall have to be replaced by the contractor and subject to reinspection.

- v. The contractor shall pay full cost of re-inspection.
- vi. The purchaser shall issue dispatch clearance after inspection and testing of materials.

### 5. Payment:

100 % of the ordered value along with full taxes and duties shall be paid after successful completion of work/supply of materials to the satisfaction of the Controlling Officer and submission of Tax Invoice in triplicate, challan in triplicate to the controlling officer of work.

## 6. Defect Liability Period:

- i. The term 'defect liability period' shall mean the period of 12 (twelve) months from the date of completion of work/receipt of materials at site. If any defect/loss is found within the defect liability period the contractor shall be liable to rectify/replace/recoup the materials at their own cost and responsibility.
- ii. Defects/loss so notified shall have to be attended and completed satisfactorily within the specified date or as deemed justified by the Controlling Officer.
- iii. If the agency denies or delays to rectify/replace/recoup the materials at their own cost and responsibility without any justified reason, the agency shall be placed in Holiday List for 3 years.
- 7. Liquidated Damages: In case of delay in delivery of materials within the stipulated time period, Liquidated Damage (LD) will be deducted @1/2% of the ordered value per week upto 10 weeks. Thereafter LD @1% of the ordered value shall be deducted per week subject to a maximum of total 10% of the ordered value.

An extension of time without imposition of LD may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted by the contractor who has to establish that the extension of time required by him was not due to his fault. **8.
