General condition of contract (GCC).

1. Technical specifications: As mentioned in Proforma of Price Bid.

2. Completion of work:

- i. The materials shall have to be delivered within 60 days from the date of issuance of order.
- ii. Dispatch clearance will be issued to the contractor after inspection and testing of materials if desired by WBSEDCL. The prospective bidder shall submit factory test certificate with his proposal for inspection/testing.
- iii. E-way bill if required shall be generated by the contractor as per prevailing norms and the same are to be submitted to the controlling officer with the challan.
- iv. The materials shall be delivered at Siliguri and the same will be transported by us.

3. Inspection & Testing:

- i. WBSEDCL may depute engineer at his own cost to inspect the materials before dispatch.
- The contractor shall arrange and provide all necessary facilities along with necessary manpower for inspection, testing at his own cost. The testing equipment must have valid calibration certificate and the same will be produced on demand.
- The contractor shall inform in 7days advance regarding readiness of materials for inspection.
- iv. The rejected materials shall have to be replaced by the contractor and subject to reinspection. The contractor shall pay full cost of re-inspection.
- v. The purchaser shall issue dispatch clearance after inspection and testing of materials.

4. Payment:

- i. 100 % of the ordered value along with full taxes and duties shall be paid after successful completion of work/supply of materials. The contractor shall have to submit Tax Invoice (triplicate) and challan to the controlling officer of work for payment processing.
- ii. The delivered materials shall have warrant against any defect in material and bad workmanship for entire a period defect liability. in case contractor will fail to comply this clause then his firm will be barred to participate in all work/NIT of JHP and his firm will be placed under holiday listing as per Norms of our Co.

5. Defect Liability Periods:

- a. The term 'defect liability period' shall mean the period of 12 twelve) months from the Date of delivery at site.
- **b.** If any defect is found within the defect liability period, the contractor shall be liable to rectify/replace the materials at their own cost and responsibility within specified date or as deemed justified by the Controlling Officer.
- c. The defect liability period of rectified/replaced materials shall be automatically extended as per 5.a.

6. Liquidated Damage:

a. If the agency fail to deliver the materials within the time specified in the Contract or any extension thereof, the Company shall recover from the contractor as liquidated damages a sum of half percent (0.5%) of the contract value of works for each calendar week of delay or part thereof of delay subjected to the **Force Majeure**.

- b. The total recovery against liquidated damage shall not exceed ten percent (10%) of the contract value of the work.
- c. An extension of time without imposition of liquidated damage may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted by the contractor who has to establish that the extension of time required by him was not due to his fault.

7. Force Majeure:

- a. The Contractor shall not be liable to pay any liquidated damage for delay/failure to perform the contract for reasons of force majeure such as acts of God, acts of the public enemy, acts of Governments, fire, flood, epidemics, quarantine restriction, strikes, freight embargos and provided that the contractor shall within 10 (ten) days from the beginning of such delay notify the Company in writing of the cause of delay. The Company shall verify the fact and grant such extension as found to be justified without imposing liquidated damage.
- b. The Department shall not be responsible or liable to pay any compensation for any interruption in your work at the site due to strike, lockout, riot, earthquake, flood, cyclone or civil commotion or any other force of accident due to any reason beyond control. The Department shall not be held responsible to or liable to pay for any interruption in your work at the site arising out of resistance from the local public due to any resistance towards work.
- 8. WBSEDCL's right to terminate the order/contract: If the agency fails to supply the materials within the time prescribed herein or extended time for supply, the notice will be issued to the agency seeking reasons for failure to supply the materials within prescribed time. If the agency fails to respond or furnish unsatisfactory reasons against the said notice, the order placed on the agency will be terminated and the agency may be subjected to holiday listing as per company's policy.
