3. Eligibility criteria for participation in tender:

- i. The bidder must have successfully completed similar works (*defined below) successfully having value not less than 50 % of the estimated cost in a single contract during last 3 (Three) years from the date of this Notice Inviting Tender under the authority of State/Central Government, State/Central Government Undertakings, Statutory Bodies constituted under the statute of Central/State Government. [Non-statutory Documents]

(*SIMILAR WORK: Any civil works related to building works of new construction/repair/refurbishment/maintenance or roof shed works or painting works etc. under the authority of State/Central Government, State/Central Government undertaking, Statutory Bodies constituted under the statute of Central/State Government.)

Note: Copy of Completion certificate and Relevant Work Order/Letter of Award/Work Order shall be submitted with the bid in this regard. Completion certificate should clearly indicate name of work, Executed value of work, date of commencement, date of completion, Letter of Award/Award of Contract/Work Order No. The Completion Certificate of concerned statutory body of Central or state government will be treated as valid credential. Letter of Award/Award of Contract/Work Order without any completion certificate will not be accepted as valid credential.

ii. **PAYMENT CERTIFICATE of Submitted Credential for Works Executed in Departments Other than WBSEDCL:** To fulfill the eligibility criteria mentioned in Clause No. 3 (i) of this NIT, submission of a copy of the payment certificate is mandatory for any credential submitted in support of work executed under any department or statutory body of the Central or State Government, other than WBSEDCL. [Non-statutory Documents].

iii. All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax receipt Challan, Up to date valid Professional Tax receipt Certificate, E.P.F. Registration, Up to date E.P.F. Challan (at the latest, by at least Three months from the date of floating of Tender), E.S.I. Registration (If applicable), Up to date E.S.I. Challan (at the latest, by at least Three months from the date of floating of Tender), GST Registration Certificate, GST return copies (All GSTR-3B copies for the last two (2) years from the date of issuance of this tender), PAN Card, Valid Trade License in respect of the prospective Bidder and Income Tax Return for last three years, Information (If any) regarding any past and current litigation with WBSEDCL/WBSETCL/Govt/PSU in which bidder is involved, the party's concerned and disputed amount.

v. Neither prospective Bidder nor any of the constituent partners had been debarred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertakings/ Enterprise etc. during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders) on Bidder's Letterhead. [Non-statutory Documents]

vi. The prospective Bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]

vii. No conditional / Incomplete Tender will be accepted under any circumstances.

4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.

The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
11. Prospective applicants are advised to note carefully the eligibility criteria for participation as mentioned in the NIT before tendering the bids.
12. Exemption from earnest money deposit (EMD) shall not be allowed under any circumstances.
13. Conditional / Incomplete tender will not be accepted under any circumstances.
14. Bidders are to keep track of all the Addendum/Corrigendum issued with a particular tender and upload all the above duly digitally signed along with the NIT. Tenders submitted without the Addendum/Corrigendum will be treated as informal and liable to be rejected.
15. The intending Bidders are required to quote the rate online.
16. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
17. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.
18. The eligibility of a Bidder will be ascertained on the basis of the documents submitted by a Bidder in support of eligibility criteria. If any document submitted by a Bidder is either Incorrect / manufactured / fabricated or false at any stage, his Tender will be out rightly rejected and legal action will be taken against him.
