 - Valid Electrical Contractor's License issued by the Licensing Board, Government of West Bengal/India under Act with valid Electrical Supervisor's Certificate of Competency (SCC) Part No. 1,2,3,4,6A,6B,7A, 7B, 11& 12 issued by the Licensing Board, Government of West Bengal/India (current engagement of electrical Supervisor at prospective bidder's firm needs to be established).
 - Valid Professional Tax Payment certificate
 - Valid Trade license (if bidder is Proprietorship Firm) or Partnership Deed & Trade License (if bidder is partnership firm) or Incorporation certificate & Trade License (if bidder is Limited Company) or Society Registration copy & Trade License (if bidder is Co-operative Society)
 - GST Registration Certificate.
 - PAN Card.
 - EPF registration Certificate.
 - Income Tax Return for Assessment Year: for the last three years.
 - Valid ESI No. (If applicable).
- 6) Neither prospective Bidder nor any of the constituent partners had been barred to participate in any Tender by any Government Department/Semi-Govt./Govt. Undertaking/ Enterprise etc during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility.
- 7) The prospective Bidders or any of their constituent partner shall neither have abandoned any work

- 8) **EARNEST MONEY:** Tenderers shall have to submit the Earnest Money of amount as mentioned in this NIT along with the Bid in the form of Account Payee Demand Draft/ Bankers cheque drawn in favour of "West Bengal State Electricity Distribution Company Ltd." payable at Siliguri, West Bengal in a separate envelope super scribing thereon "Earnest Money". Earnest money in any other form will not be accepted. Tender without earnest money will be rejected summarily.
 - 9) The bidder at the bidders own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense.
 - 10) Bid shall remain valid for a period not less than 120 (One Hundred Twenty) days from the date of opening of tender. If the bidder modifies/ withdraws the bid during the validity period of bid, the bid will be cancelled with forfeiture of earnest money (EMD).
 - 11) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the WBSEDCL. The WBSEDCL reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder at any stage of Bidding.
 - 12) Revised purchase policy will be followed wherever applicable in respect of the contract work. Revised purchase policy is available at company's website.
 - 13) Prospective applicant is advised to note carefully the minimum qualification criteria before tendering the bids.
 - 14) Exemption from deposition of earnest money deposit (EMD) shall not be allowed under any circumstances.
