

- I. **Delivery of material:** Within 45 (Forty Five) days from the date of issuance of the order.
- II. Place of delivery: The materials will be delivered at PPSP Site Store, WBSEDCL. Bagmundi, Purulia
- III. **Price**: Price should be firm inclusive of all incidental charges. GST value and percentage to be written separately in quotation. However, GST will be applicable as per law of land at the time of placement of order. STDS will be deducted as per norms.TDS will be applicable as per the IT Act.
- IV. **Delivery Charge**: Delivery charge will be borne by the Agency.
- V. Payment: Ninety percent (90%) of the contract value will be paid preferably within 45 (Forty-Five) Days after successful delivery and acceptance of materials. Ten percent (10%) will be retained as Security Deposit (SD). Materials will be received at site through raising Store Receipt Voucher (SRV). Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency at time of delivery. In case of part delivery of materials payment will be made accordingly. Payment will be made through R.T.G.S/N.E.F. T (R.T.G.S/N.E.F. T charge to be borne by the Agency).
- VI. **BG/BD**: 10 % of the quoted value as additional performance security will have to deposited, if the bidder quotes in the range of -20% to -80%.

- X. Liquidate Damage: Penalty for delay in work @1/2% (Half percent) of value of order for each week delay or part thereof upto ten (10) weeks and @1% of the order value per week or part thereof beyond ten (10) weeks subject to maximum limit of 10% (Ten percent) will be deducted from your bill.
