3.0 SUBMISSION OF TENDER:

The tender will be submitted in two bid systems i.e. Techno-Commercial bid & Financial bid, online only through the Website www.wbtenders.gov.in

4.0 ELIGIBILITY CRITERIA OF THE BIDDER:

4.1 Technical :

The bidder must have successfully completed construction of similar nature of work having contract value not less than 50% of the estimated cost in a single contract during last three years for the said work in a single order. All the required License and enlistment must be produced for such kind of Works.

4.2 Commercial & Financial :

4.2.1 The average annual turnover of the bidder for best two years out of the financial years 2021-22, 2022-23, 2023-24 shall be minimum 8(Eight) lakhs for the said work (Annexure-I).

4.2.2 The working capital and credit facility taken together either for 2019-20, 2020-21, 2021-22, 2022-23, 2023-24 shall be minimum 9 (Nine) lakhs for the said work (Financial Capability proof certificate from bankers, one year from date of Publication of NTT).

(Financial Capability proof certificate from bankers, prior one year from date of Publication of NTT).

4.3 The Bidder must include following documents to substantiate the qualifying requirement

information to make RTGS/NIFT payment using his bank account. Once the payment is made, the bidder will come back to e-procurement portal to continue the bidding process after expiry of a reasonable time to enable the RTGS/NIFT process to be completed.

iii. Submission of EMD through BG: For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT. EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. Partial payment through online mode and remaining submission through BG is not allowed.

B) GENERAL INSTRUCTIONS FOR ONLINE PAYMENT OF EMD :

- i.** The bidder will have to mandatorily pay through Net-banking facility once Net-banking mode is opted for payment.
- ii.** Status of NIFT/RTGS payment through Challan for a bid may take time for bank settlement which is updated in 24 Hrs. (approx.). As such bidders opting to pay through NIFT/RTGS mode shall make payment well before 24 Hrs. to avoid any complicity.
