The Project Manager, Jaldhaka Hydel Project, WBSEDCL invites tender (Submission of Bid through offline) on percentage rate basis for the works detailed below from bonafide, resourceful and experienced contractors of State / Central Govt., State / Central Govt. Undertaking, Statutory Bodies constituted under the statute of Central / State Govt. as per following terms & conditions:

Terms & Conditions:

1. **Name of Work:** " Testing of high pressure vessels, reservoir, equipments ,tools and tackles for Stage-I and Stage-II Power House under Jaldhaka Hydel Project Dist. Kalimpong 734503"
2. **Scope of work:**
 - a. The successful agency shall have to depute his testing personnel with valid calibrated testing equipments for above work.
 - b. The successful agency shall submit test certificate with clear mentions of validity of test.
3. **Estimated value:** Rs. 65,350/- (Rupees sixty five thousand three hundred fifty only) excluding of GST. GST shall be paid extra as per norms.
4. **Submission of bid:** The contractor shall positively submit his bid within 15-02-2025 in tender box or by hand/Indian post. Tender via other means will not be accepted. In case, the schedule date fall/declared holiday than the next working day will be considered.
5. **Completion of work:** The work shall have to be completed within 15 days from the date of site handover.
6. Intending bidders may download the tender documents from the website www.wbasedcl.in or make copy from Notice board or submit written request for issue of tender document. Only soft (PDF) copy will be provided to the prospective bidder, hence Tender Cost /Tender Fees are abolished for Tendering. All participating bidders are therefore exempted from payment of Tender Fees.
7. **Technical Eligibility criteria:** The agency shall have minimum qualifying criteria as mentioned below:
 - a. GST certificate
 - b. PAN certificate.
 - c. Experience in successful completion of similar nature of work in any central Govt.,

central PSU, state Govt., state PSU or any power utility within last 7 years from the date issue of this NIT.

- 8. Financial Bid:** Financial bid is to be submitted as per prescribed proforma attached in this tender.
- 9. Bid Validity:** Bids shall remain valid for a period not less than 180 (one hundred eighty) days from the last date of submission of Bid. If the bidder modifies/withdraws the bid during the validity period of bid, the bid will be cancelled.
- 10. Amendment of the Bid Documents:** The tender inviting authority reserves the right to modify, amend or supplement the tender document. Any corrigendum, notification concerning this tender will be published will be treated as part and parcel of the tender. The bidders are, therefore, advised to follow the website for such corrigendum, notification etc.
- 11. Cancellation of Tender:** The WBSEDCL also reserves the right to cancel the Tender due to unavoidable circumstances and no claim in this respect will be entertained.
- 12. Rejection of Bid:** The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever. No conditional bid and/or incomplete bid will be accepted under any circumstance.
- 13. Liability Of Accidents And Damage:** The Contractor shall be responsible for the loss, damage or depreciation of the Company's materials while in their custody and until the same is taken over by the Company. Until the completed work is taken over by the Company the contractor shall also be liable for and shall indemnify the Company in respect of all injury to person or damage to property resulting from the negligence of the contractor or his workmen or sub-contractor or from defective workmanship etc.
- 14. Settlement Of Disputes:** All disputes concerning question of act arising under the contract shall be decided by the owner/company on receipt of written appeal by the contractor. Any dispute or differences arising out of or in connection with this contract shall to the extent possible be settled amicably and where settlement cannot be reached then such disputes shall be subject to settlement under the jurisdiction of Calcutta High Court.
- 15. Cancellation/ Terminating of The Order:** In case the contractor discontinues the work within the contract period, the Company reserves the right to get the work done by any other contractor and realise any damages and losses to the company from contractor's bills. The order may be cancelled/ terminated at any point of time during the contractual period by the company without assigning any reasons whatsoever by serving 7 days' notice for unsatisfactory performance as may be observed by the Controlling Officer.

16. **Paying Authority:** The Manager (F&A), JHP shall be the paying authority.
17. **Controlling Officer:** The Divisional Engineer (Elect.), St-I and St-II, Power House JHP
18. **Supervising Officer:** The Assistant Engineer (Mech.), St-I and St-II JHP or the authorised officer of controlling officer.
19. **Nodal Officer:** The Assistant Manager (HR & A), JHP.
20. **Official Communication:** All the important correspondence must be done through declared authorized email id with original scanned copy of documents/letter in company's letter head/pad. INSTRUCTION TO BIDDERS (ITB)

1. Eligibility criteria: As per NIT.

2. Submission of Tenders:

- a. Tenders are to be submitted in two parts one is Technical part and the other is financial part. The bidder shall carefully go through the documents before submission of tender.
- b. The bidder shall scribe Name of work, NIT No and schedule date of opening on all envelopes meant for technical and financial part and encloses these two parts in third envelope and sealed properly. The third envelope should scribed Name of work, NIT No and schedule date of opening on third envelope.
- c. All envelopes shall be duly sealed and properly addressed to the tender inviting authority.
- d. **Technical part:** Technical part should contain singed copies of the followings.
 - i. NIT
 - ii. GST Registration Certificate.
 - iii. PAN Card.
 - iv. Experience in similar nature of work in any central Govt., central PSU, state Govt, state PSU within last 7 years from the date issue of this NIT.
- e. **Financial Part:** It contains Bill of Quantities (BOQ). The rate is to be quoted in the BOQ on "percentage rate basis" in the space marked for quoting rate in specimen of proforma of price bid.

3. Opening and evaluation of tender:

- i. Technical part will be opened first by the Tender Inviting Authority or his authorized representative. Intending bidders may remain present if they so desire. If there is any deficiency in the technical part, the tender of respective bid will summarily be rejected.
- ii. While evaluation, the Tender Inviting Authority or his authorized representative may summon the bidders and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated timeframe, their bid proposals will be liable for rejection.
- iii. The summary list of bidders, whose bids will be found technically responsive, will be noticed on the notice board of tender inviting authority with due date of opening of financial bid. Financial part of the bidders declared techno-commercially eligible, will be opened on prescribed date and time at

the office of the tender inviting authority. After opening of the financial part the preliminary summary result containing inter- alia, name of bidders and the rates quoted by them will be noticed on the notice board of tender inviting authority

- iv. The Tender Accepting Authority may ask any of the bidders to submit analysis to justify the rate quoted by that bidder.
 - v. Revision/withdrawal of Financial part by the bidder after opening of Technical part of the tender will not be allowed if it is not sought by the Tender Inviting Authority
 - vi. **Acceptance of Tender:** Lowest valid rate should normally be accepted. Evaluation of bid will include and will take into account Cost of total Scope of Work excluding Taxes. However, the Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the tenders, for valid reasons.
 - vii. **Concession:** No price preference will be allowed to any bidder based on the size of the industry or its geographic location. Co-operative Society will not be considered with separate status.
- 5. Laws governing contract:** The contract shall be construed according to acts/laws in force in the country and shall be under the jurisdiction of Calcutta High Court.
- 6. Language and measures:** All documents pertain to the contract including specifications, schedule, notice, correspondences, operating and maintenance instructions, drawings or any other writings be written in English language. The metric system of measurement shall be used exclusively in this contract.
- 7. Award of contract:**
- i. The Bidder whose Bid would be accepted will be notified by the authorized official through acceptance letter/Letter of award/ Purchase order.
 - ii. The notification of award will constitute the formation of the Contract.
- 8. Right to reject bids:** WBSEDCL reserve the right to accept or reject any bid to and the bidding process and reject all the bids at any time prior to award of contract without **thereby** incurring any liability to affected bidder or bidders or any obligation to inform the affected bidder or bidders the reason for WBSEDCL's action.
- 13. Taxes, duties and other levies:**
- i. The contractor shall be solely responsible for the taxes that may be levied on the contractor's persons or on earnings of any office employee and shall hold the purchaser indemnified and harmless against any claims that may be made against the purchaser. The WBSEDCL does not take any responsibility whatsoever regarding taxes under Indian Income Tax Act for the contractor or his personnel. If it is obligatory under the provisions of Indian Income Tax Act, deduction of Income Tax at source shall be made by WBSEDCL.

- ii. All other taxes/duties/levies/cess payable by the bidder except GST shall be included in the bid price and no claim on this behalf will be entertained by WBSedCL. GST will be paid extra as per prevailing rules.

14. Additional Performance Security: If the lowest bidder's bid is found to be within the range of -20% to -80% of the estimated value, the bidder shall have to furnish an Additional Performance Security amounting to 10% of the tendered amount. The Additional Performance Security shall be submitted in the form of Bank Guarantee from any scheduled bank before issuance of Work Order. The Additional Performance Security shall have validity for entire defect liability period and with a claim period of another 3(three) months. Tenderer shall not claim any interest on Additional Performance Security. Additional Performance Security may be extended or revised as per the request of purchaser.

4. **Payment::** 100 (hundred) % of the ordered value along with full taxes and duties shall be paid subject to submission of security deposit(as mentioned as per Sl. No. 5) against delivery challan and Tax Invoice in-triplicate.

5. **Security Deposit:**

- a. For the due performance of the Contract, the Contractor shall, within 30 days from the receipt of Letter of Award, a security deposit for an amount equal to 10 % (Ten percent) of the Contract price.
- b. In case the non-submission of security deposit equivalent sum of security deposit will be deducted from 1st or other bills for security deposit.
- c. **Additional Performance Security:** An Additional Performance Security @ 10% of the tendered amount shall have to be submitted by the successful bidder in the form of a DD issued from any scheduled bank approved by RBI as per the enclosed format before issuance of the work order if the accepted bid value is in the range of -20% to -80% of the estimated rate.
- d. **Release of security deposit:** After completion of defect liability period, and on completion of satisfactory rectification of defects, if any reported within the defect liability period, and on receipt of the application from the contractor the controlling Officer of the work will recommend release of security deposit.

6. **Defect Liability Period:**

- a. The term 'defect liability period' shall mean the period of 12 (twelve) months from the date of completion of work. If any defect/loss is found within the defect liability period, the contractor shall be liable to rectify/replace/recoup the materials at their own cost and responsibility.
- b. Defects/loss so notified shall have to be attended and completed satisfactorily within the specified date or as deemed justified by the Controlling Officer. For faithful & due fulfilment of all obligations, this defect liability period shall be

covered by Security Money, already submitted by the contractor as mentioned above.

- c. After completion of defect liability period, and on completion of satisfactory rectification/recoupment of defects/loss, if any, reported within the defect liability period and on receipt of the application from the contractor the controlling Officer of the work shall recommend for release of the security money.

7. Liquidated Damages:

- a. In case of delay in successful completion of work in its entirety within the stipulated time period, Liquidated Damage (LD) will be deducted @1/2% of the ordered value per week or part thereof up to 10 weeks. Thereafter LD @1% of the ordered value shall be deducted per week or part thereof subject to a maximum of total 10% of the ordered value.
- b. An extension of time without imposition of LD may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted by the contractor who has to establish that the extension of time required by him was not due to his fault. The approval of such extension is subject to approval from competent authority of WBSedCL.

8. Force Majeure:

- a. The Contractor shall not be liable to pay any liquidated damage for delay / failure to perform the contract for reasons of force majeure such as acts of God, acts of the public enemy, acts of Governments, fire, flood, epidemics, quarantine restriction, strikes, freight embargos and provided that the contractor shall within 10(ten) days from the beginning of such delay notify the Company in writing of the cause of delay. The Company shall verify the facts and grant such extension as found to be justified without imposing liquidated damage.
- b. The department shall not be responsible or liable to pay any compensation for any interruption in your work at the site due to strike, lockout, riot, earthquake, flood, cyclone or civil commotion or any other force of accident due to any reason beyond control. The department shall not be held responsible to or liable to pay for any interruption in your work at the site arising out of resistance from the local public due to any resistance towards work.

9. Company's right to terminate the contract:

- a. If the contractor neglects or fails to proceed with the work/supply proportionate to the scheduled time of completion of the work or fails to complete the work

within scheduled time for completion or within the extended time approved by the company, the company shall have the right to terminate the order/letter of intent after giving notice in writing to the contractor. If the contractor fails after 14 days of such notice, to proceed with the work in the manner notified, the company shall terminate the contract and call the contractor to take joint measurement along with the Engineer for the finished portion of work. If the contractor does not appear for a joint measurement, ex party measurement by the company will be taken as final.

b. In that case the company shall take possession of the work site and may engage other agency to complete the work/ supply the required materials. Extra cost if incurred to get the job done through other agency will be realized from him, from his pending bills and security money. If the contract is terminated as above, the contractor shall have no claim for compensation against the company for any loss or deterioration of any materials that he may have collected or engaged or entered into on account of the work.

10. **Risk Purchase:** - The time of delivery (offer for inspection) or physical dispatch stipulated in the purchaser order shall be deemed to be of the essence of the contract and if the supplier fails to deliver or inspection any consignment within the period prescribed for such delivery or dispatch in the said purchase order /contract/letter of intent ,the purchaser shall be entitled to purchase such consignment if not available , the best and nearest available substitute elsewhere on the account and at the risk of the supplier or to cancel the contract and the supplier shall be liable to compensate for any loss or damage which the purchaser may sustain by reason of such failure on the part of the supplier tender is not executed fully .
11. The tenderer shall indemnify any damages/ defect caused of WBSEDCL property by his personnel during service period. WBSEDCL will not liable for any accident caused due to vendor's negligence
