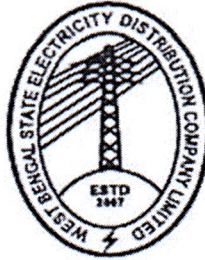

### **Terms & Conditions**

#### **1. Techno-Commercial Requirements of the Bidder (Must Conditions):**

A. The intended bidder must have :-

1) Valid PAN, GSTIN, EPF code, PTPC.

2) Successfully completed similar work(s) during the last 7 (seven) years with fulfillment of any of the following criteria :

- Three similar works, each costing at least 40% of the estimated value in a single contrite, or
- Two similar works, each costing at least 50% of the estimated value in a single contract, or,
- One similar work, costing at least 80% of estimated value in a single contract.

(Note: Any civil works, either construction or maintenance nature, will be treated as 'similar work' for interpretation under sl. no. 3 above)

3) Working capital in the year preceding the year of bid submission not less than 30% of the estimated value(to be judged by adding available credit facility & working capital together, in case documents certifying credit facility from a scheduled Bank is submitted).

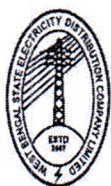
4) Average annual turnover during last 3 (three) years not less that 30% of the estimated value.

2. Necessary documents as specified in IB.5 of this bid document shall have to be uploaded with the bid for substantiating the eligibility criteria above.

3. For e-filling of bids, intending bidder shall download bid documents from the website: <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Both Techno-commercial Bid and Price Bid are to be submitted concurrently, duly digitally signed, in the same website within time schedule given below.

4. Earnest Money Deposit shall be mandatorily deposited online through the website <https://wbtenders.gov.in> via Net-banking via Payment Gateway or RTGS/NEFT Payment, as elaborated in the Section "Instructions to Bidders" of the bid document. There is no option for offline submission of EMD through DD/Pay order/Banker's cheque etc. Only Bank Guarantee is accepted. There is no tender cost for this tender.
