1. **Name of Work:** "DESIGN, ENGINEERING, MANUFACTURING, SUPPLY AND SUPERVISION OF INSTALLATION, TESTING AND COMMISSIONING OF ONE (01) NO. VERTICAL TURBINE PUMP-MOTOR SET AT RAMMAM HYDEL PROJECT, STAGE-II, WBSEDCL, DIST. - DARJEELING, PIN - 734201"
2. **Estimated Amount:** Rs. 15,00,000.00/- (Rupees Fifteen Lakh only), without GST.
3. **Earnest Money:** Rs. 30,000.00/- (Rupees Thirty Thousand only)
4. **Eligibility Criteria:** The Bidder must possess minimum eligibility criteria as mentioned below:
 - a. The Bidder should be OEM/OEM authorized channel partner of Pump Motor Set.
 - The OEM should have technical service setup in India.
 - If the bidder as an authorized Channel partner/representative of OEM, he should submit a valid authorization letter from OEM for the tender along with necessary certificate/confirmation/undertaking from the OEM of the Pump Motor set confirming/complying to the tender specifications.
 - b. The bidder(s) should satisfy the following minimum eligibility criteria as under:

The bidder must have successfully completed any of the following during last 07 (seven) years, reckoned from the date of publication of this tender.

Three (03) similar works each costing not less than the amount equal to 40% of the estimated value of the tender,

Or,

Two (02) similar works each costing not less than the amount equal to 50% of the estimated value of the tender,

Or,

One (01) similar work each costing not less than the amount equal to 80% of the estimated value of the tender

Note:

- Work experience certificate from private individual shall not be considered.
- Similar work means: "Supply and Delivery of Multistage Pump motor Set"

In support of the above, the bidders shall submit the Letter of Award (LOA) and/or Delivery/Completion Certificate duly signed by respective ordering authority.

The bidder(s) must be an established, experienced and reputed firm and have regularly undertaken works of the similar type tendered for and have adequate technical knowledge and practical experience in field.

- c. License in respect of prospective bidder such as Proprietorship Firm (Trade License), Partnership Firm (Partnership deed, Trade License), Ltd. Company (Incorporation Certificate, Trade License).
- d. The bidder must possess & submit the following documents along with the bid.
 - Documentary proof i.r.o. OEM/OEM authorized channel partner of Pump Motor Set
 - Proof of experience as per Sl. No. 4.b above.
 - Employees' Provident Fund (Registration)
 - Up to date Professional Tax challan.
 - GST Registration Certificate
 - Trade License
 - PAN No. & IT Return for last three (03) years.

The Bidder shall produce original copy of the documents i.r.o. eligibility criteria, if so, required by WBSEDCL. Any discrepancies found by the tender inviting authority may lead to rejection of the bid and forfeiture of the earnest money.

7. Scope of Work:

DESIGN, ENGINEERING, MANUFACTURING, SUPPLY AND SUPERVISION OF INSTALLATION, TESTING AND COMMISSIONING OF ONE (01) NO. VERTICAL TURBINE PUMP-MOTOR SET AT RAMMAM HYDEL PROJECT, STAGE-II, WBSEDCL, DIST. - DARJEELING, PIN - 734201.

8. **Validity:** The tender shall be valid for one hundred and eighty (180) days from the date of opening of technical bid. If the bidder modifies/withdraws his bid during

the validity period of bid, the bid will be cancelled with forfeiture of Earnest Money Deposit (EMD).

9. Conditional / Incomplete tender will not be accepted under any circumstances.
10. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other document submitted by the Bidder is incorrect / manufactured / fabricated, or false at any stage, that bidder would not be allowed to participate in the tender and his Tender will be rejected with forfeiture of earnest money and legal action may be taken against him.
11. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s). WBSEDCL reserves its right to take decision keeping its financial interest.
12. WBSEDCL reserves the right to:
 - Amend the scope of work to be tendered.
 - Reject any or all the offers without assigning any reason whatsoever at any time prior to the Award of Contract, without thereby incurring any liability to the affected bidder(s); and
 - Cancel the bidding process and reject all bids, without assigning any reasons thereof.

WBSEDCL will not be liable for any such actions. However, the bidder(s), who wish to seek reasons for such decision of cancellation / rejection, shall be informed by WBSEDCL unless its disclosure reasonably could be expected to affect the sovereignty and integrity of India; the security, strategic, scientific or economic interest of the State; relation with foreign state or lead to incitement of an offence. In such case, the Earnest money submitted by the bidder(s) will be refunded to the bidder without any interest.

13. WBSEDCL reserves the right to assess the bidders' capacity and capability to perform the contract and may relax the qualifying requirements at any stage, if required.
