1. **Delivery Period:** Within 45 Days from issuance of order.
2. **Place of delivery:** The materials shall be delivered at PPSP Site Store, WBSEDCL, Bagmundi, Purulia – 723152 (W.B).
3. **Price:** Price should be firm inclusive of all incidental charges. GST should be mentioned separately as applicable.
4. **Payment:** 95% Payment will preferably be made after successful delivery of materials at site, drawal of Store Receipt Voucher from this end and on submission of original bill/ Tax Invoice in triplicate with advanced pre-receipt (Duly signed on Revenue Stamp), Guarantee/Warranty Certificate & challan which are to be submitted at the time of delivery of materials. Payment will be made by RTGS/NEFT whose charge shall be borne by the agency. All the statutory **deduction** as per law/act and any deduction which WBSEDCL may make under the contract shall be made from your claimed bill as applicable.
5% shall be kept as **Security Deposit** which shall be refunded after expiry of guarantee/warranty period. No claim shall be made against WBSEDCL in respect of interest on Security Deposit.
5. **Taxes:** Applicable GST shall be paid on submission of claims in the GST Tax invoice. TDS, STDS under GST and other statutory deduction as applicable will be deducted from the bill. You shall not impose TCS U/S 206C (1H) of Income Tax Act 1961, as WBSEDCL is liable to deduct TDS as per section 194Q of Income Tax Act 1961.

10. **Transit Insurance:** In the scope of the supplier.

12. **Packing & Forwarding:** The materials should be duly packed taking all reasonable precautions to protect the materials against damage and loss during transit. The bidder will bear total responsibility against any losses & damages during transit.
13. **Penalty:** *Penalty for delay in delivery @0.143 % of the value of materials of particular lot offered/or delivered beyond the stipulated delivery period for each day of delay, subject to maximum of 10% of the value of the particular lot and accept the goods beyond the stipulated period.*
14. **Guarantee:** Original manufacturer/ Supplier's Guarantee/warranty is to be provided for a minimum period of 12 months from the date of successful delivery of the materials. In case the supply materials are beyond our specification or found defective/damage /broken within the Guarantee / warranty period, the same should be replaced by the agency at their own risk, cost and responsibility within 15 days of intimation.
15. **Freight:** It will be borne by the agency.
16. **Validity:** The offer must remain valid for 60 days from the date of opening of the tender.
17. **Rejection:** WBSEDCL reserves the right to reject any or all offer at its own discretion without assigning any reasons whatsoever and do not bind itself to accept the lowest tender.
18. **Additional Liabilities:** The WBSEDCL shall not take any additional liability towards Enhanced taxes, duties beyond the scheduled delivery period as incorporated in the purchase order, if the delay is due to any failure on the part of the supplier.
19. **Additional performance Bank Guarantee:-**
 - i) Additional Performance Security equal to 10% of the ordered value for bid of the items having variation of -20% to -50% of the estimated rate should be furnished in the prescribed format, within a period of 30 days from the date of issuance of the Purchase Order
 - ii) Additional Performance Security equal to 20% of the ordered value for bid of the items having variation over -50% to -80% of the estimated rate should be furnished in the prescribed format, within a period of 30 days from the date of issuance of the Purchase Order. This Security Deposit (i) & (ii) above shall remain valid upto the time of completion of service(s)/supply of materials, with an additional claim period of further six months.



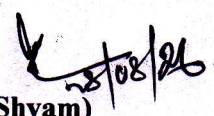
20. **ISSUE & SUBMISSION OF E-WAY BILL (If Applicable):** E-Way Bill shall be generated by the supplier for the movement of materials/equipment from manufacturer's unit location to the WBSEDCL stores. WBSEDCL's GSTIN is 19AAACW6953H1ZX.
E-Waybill if required maybe generated from the portal by the supplier.
The utilization report is to be submitted to Sr. Manager (F&A) Indirect Tax Cell, WBSEDCL, Vidyut Bhawan, 6th Floor within 03 days.
21. **Risk Purchase Clause:** The time of delivery stipulated in the purchase order shall be deemed to be of the essence of the contract and if the supplier fails to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch in the said purchase order/contract/letter of intent, the purchaser shall be entitled to purchase such consignment or if not available, the best and nearest available substitute elsewhere on the account and at the risk of the supplier or to cancel the contract and the supplier shall be liable to compensate for any loss or damage which the purchaser may sustain by reason of such failure on the part of the supplier. The Company at its discretion may not issue subsequent tender if earlier Purchase Order against earlier tender is not executed fully. If there is a failure to execute the contract fully, WBSEDCL reserves the right to invoke Bank Guarantee/forfeit Earnest Money deposit/cash security to the extent of loss so suffered by the WBSEDCL on risk purchase or otherwise, and may deduct the additional amount, if any, so incurred by the Company from other claim / bill lying with the WBSEDCL.
22. **Force Majeure:** - The supplier shall be under no liability if he is prevented from carrying out any of his obligations by reason of war, invasion, act of foreign country, hostilities (whether war declared or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods, Govt. order and/or restrictions (except power supply restriction) delay or inability to obtain materials due to import or other statutory restriction and other cause beyond the reasonable control of the supplier. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper documents/proofs to the entire satisfaction of the purchaser.
23. **Legal Jurisdiction:** -
If any dispute or difference arises with respect to quality/quantity of the equipment/materials/ work pertaining to this order or any other terms and conditions of the order including its execution, such dispute/difference shall be subject to settlement under the jurisdiction of Courts in Kolkata only.
24. **Site Visit for Sample Inspection:** Authorized representatives of interested agencies can view the sample of items physically at PPSP Site, Baghmundi if required. Necessary transportation, accommodation etc for site visit has to be arranged by the agency at their own cost, risk and responsibility.



25. **Evaluation:-** Evaluation of the tender will be done on **Overall Price.**
26. **Non Compliance:-** In case of non-compliance of the order by the L1 bidder, necessary action will be taken as per norms of WBSEDCL. It may also lead to holiday listing of L1 bidder.

Note: * Any Offer submitted after the expiry of the time prescribed for submission or Incomplete in any respect shall be rejected. Late receipt of Offer in case of postal delivery will not be considered. Offer by FAX/E-mail will not be accepted.
