5. **How to Participate:** Intending bidders will have to download and print the tender from our website www.wbsedcl.in under tender. 6. The Technical Part shall contain NIT duly signed at each pages, EMD, eligibility criteria part, request letter (Annexure-I) and check box. The Price Part shall contain the Tender Form.
7. The interest bidders may visit the site for examine the works required for preparing the Bid. The cost of visiting the site shall be at the Bidder's own expense.
8. The tenderers shall keep the Technical part and price part in two separate covers and shall seal it properly. These two inner covers shall be addressed to the Project Manager, TCFHP, WBSEDCL, Phansidewa Township complex, WBSEDCL, Dist: Darjeeling-734434 and shall contain the name of work, tender Notice no. and shall be super-scribed as "TECHNICAL PART" and "PRICE PART" as the case may be. These two sealed inner covers shall be put into an outer cover and be sealed properly.
9. The outer sealed envelope containing the "TECHNICAL PART" and "PRICE PART" in separate sealed covers as stated above, shall be addressed to the Project Manager, TCFHP, Phansidewa Township complex, WBSEDCL, Dist: Darjeeling-734434.
10. Tender Notice No, Due date and name & address of the bidder must be prescribed on the envelope covering the tender.
11. All the papers enclosed with the tender must be signed & sealed by the authorized signatory of the tender.
12. Bid submitted shall remain valid for a minimum period of 180 (one hundred eighty) days from the next date of opening of tender. However, WBSEDCL may, on the merit of case, request extension of validity of the offer for a further suitable period without any change in terms & conditions of the offer.
13. Conditional / Incomplete tender will not be accepted under any circumstances.
14. Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.

15. If the above mentioned office happens to be closed on the date of receipt of application and/or on the date of issue of the Bid Documents and/or on the date of receipt/opening of Bid documents, the next working day at the same time and venue shall be applicable for the said purpose.
16. The WBSEDCL does not bind itself to accept the lowest bidder and reserves the right to reject any or all tender(s) or to split the whole work to more than one contractor without assigning any reason whatsoever.
17. The WBSEDCL reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
18. **Refund of EMD:** In case of unsuccessful bidders, Earnest money Deposit will be refunded after finalization of the tender in the bank account as provided in the **Annexure-I** (To be filled up by the bidder on bidder's own letter head). For successful bidder it will be refunded after receipt of materials at site.
19. **Forfeiture of Earnest Money:** Earnest Money shall be forfeited in case of following:
 - i. If during the period of validity, the bidder withdraws its bid as a whole or in part.
 - ii. If the bidder deviates from any clarification/confirmation given by him subsequent to submission of his bid.
 - iii. In case of successful bidder, if the Bidder fails to accept LOA/Order unconditionally.
20. **Evaluation of Bid:** The bids shall be evaluated on the basis of total quoted price for the entire scope of supply covered under this bid document.
21. **Completion time:** Delivery of the items should be completed within 30 (Thirty) days from the zero date. The zero date will be reckoned the date of received of L.O.A vide (A) by hand (B) by e-mail or any electronic media and (C) by post, whichever is earlier.
22. **Delivery Destination:** Materials shall be delivered by you to TCFHP Store, Power Station-I, Teesta Canal Fall Hydel Project (TCFHP), West Bengal State Electricity Distribution Company Limited (WBSEDCL), Leusipukri, Distt: Darjeeling-734434 at your own cost & responsibility.
23. **Defective materials:** If in the opinion of the Engineer-in-Charge, any of the materials supplied is not of the quality of kind specified in the contract and /or are unfit for the works, he shall be at liberty to reject the materials and the contractor shall re-supply the same as directed by the Controlling Officer.
24. **Manufacturer Warrantee Certificate:** The successful bidder shall have to submit the manufacturer warrantee certificate for the materials.
25. **Payment:** Consignee Officer, on receipt of goods will issue a Store Receipt Voucher (SRV) and forward the stamped and pre-receipted GST prescribed invoice in triplicate to the Controlling Officer. He in turn certify the invoice for processing and releasing payment by Paying Officer. Payment will be made through NEFT/RTGS to you. Necessary Bank charges will be borne by you. You need to provide your A/C details such as IFSC code along with bill to be submitted in GST prescribed format.

28. **Consignee Officer:** The Assistant Engineer (M) & Store In charge, Power Station-I, Teesta Canal Fall Hydel Project, Leusipukri, Dt. Darjeeling.
29. **Liquidated Damages:** Supply and delivery (physical delivery of Equipment / Materials at the place of delivery in accordance with the Delivery Instruction) /erection/construction of the Equipment /Materials as well as execution of the entire work should be as per the delivery schedule/schedule of completion of work. If the Equipment / Materials/ erection/construction are not delivered/work is not completed within stipulated period as per schedule, WBSEDCL reserves the right to repudiate the Order (LOA). But the Purchaser may, at his discretion, extend the delivery schedule/execution schedule subject to imposition of liquidated damages at half percent (0.5%) of the Contract price for per week of delay or part thereof for first 10 (ten) weeks and @ 01% of value per week beyond 10weeks subject to a maximum of 10% of the contract price /Ordered value and accept the Equipment / Materials beyond the stipulated period. Liquidated damages, if any, shall be recovered from the outstanding bills / performance guarantee.

Total contract price shall imply the contract prices of all the schedules of works taken together. The purchaser may, without prejudice to any other method of recovery, deduct the amount of such damages from any moneys due or to become due to the contractor. The payment or deduction of such damages shall not relieve the contractor from his obligation to complete the works or from any of his other obligations and liabilities under the contract.
30. **Force Majeure:** The Agency shall be under no liability if he is prevented from carrying out any of his obligations by reason of war, invasion, act of foreign country, hostilities (whether war declared or not), riots, civil commotion, mutiny, insurrection, rebellion, revolution, accident, earthquake, fires, floods Govt. orders and/or restrictions (except power supply restriction) delay or inability to obtain materials due to import or other statutory restriction and other cause beyond the reasonable control of the supplier. However, such force majeure circumstances are to be intimated immediately and to be established subsequently with proper documents/proofs to the entire satisfaction of the purchaser.
31. **Risk Purchase:** The time of delivery (offer for inspection) or physical despatch stipulated in the purchase order shall be deemed to be of the essence of the contract and if the supplier fails to deliver or despatch any consignment within the period prescribed for such delivery or despatch in the said purchase order/contract/letter of intent, the purchaser shall be entitled to purchase such consignment or if not available, the best and nearest available substitute elsewhere on the account and at the risk of the supplier or to cancel the contract and the supplier shall be liable to compensate for any loss or damage which the purchaser may sustain by reason of such failure on the part of the supplier. The Company at its discretion may not issue subsequent tender if earlier Purchase Order against earlier tender is not executed fully.

If there is a failure to execute the contract fully, WBSEDCL reserves the right to invoke Bank Guarantee/forfeit Earnest Money deposit/cash security to the extent of loss so suffered by the WBSEDCL on risk purchase or otherwise, and may deduct the additional amount, if any, so incurred by the Company from other claim / bill lying with the WBSEDCL

- 32. Extension of time:** An extension of time without imposition of penalty, may be granted for delay in execution of work provided there is no fault whatsoever on the part of the contractor. Such extension may only be granted on the basis of application to be submitted within the schedule date of completion by the contractor who has to establish that the extension of time required by him is not due to his fault.

Causes for Extension of Time for Completion: The Contractor may claim an extension of the Time for Completion if he is or will be delayed in completing the Works by any of the following causes:

- (a) Extra or additional work ordered in writing by WBSEDCL.
- (b) Suspension of work ordered in writing.
- (c) Delay by any other Contractor engaged by WBSEDCL, affecting this Contract.
- (d) The WBSEDCL's Risks, if any when they constitute the sole reason for the delay in completion of Works.
- (e) Delay in handover of site by WBSEDCL.
- (f) Force Majeure.

You shall give notice to WBSEDCL of his intention to make a claim for an extension of time within 07 days of the occurrence of any of the above cause(s). The notice shall be followed as soon as possible by the claim with full supporting details. WBSEDCL shall after verification allow you for updating of the programme chart as facts may justify

- 33. Amendment to the Letter of Award:** So far any modification / additions, if any, to this Letter of Award (L.O.A) are concerned, the extension, amendments, corrigendum, approval for excess quantities, extra items etc. issued by this office shall be considered as valid and applicable to the contract in question.
- 34. Legal Jurisdiction:** If any dispute or difference arises with respect to quality/quantity of the equipment/materials pertaining to this order or any other terms and conditions of the order including its execution, such dispute/difference shall be subject to settlement under the jurisdiction of Courts in Kolkata only.
